**APPROVAL OF REQUEST FOR PAYMENTS TO
FEE-FOR-SERVICE MENTAL HEALTH SERVICES PROVIDERS
FOR FISCAL YEAR 1998-1999
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

Approve and authorize the Director of Mental Health or his designee to finalize claims payment issues related to Fee-For-Service (FFS) providers in the amount of \$82,293 for Fiscal Year (FY) 1998-1999, as set forth in the Attachment. Finalization of claims payment will allow the providers to retain the payments received for services rendered, where the claims for payment were not approved by the State but would have been, had the County filed their claims timely. The payments were funded from the FY 1998-1999 State Managed Care Allocation provided by Agreement Number 97-77237 between the State Department of Mental Health (SDMH) and the County of Los Angeles Department of Mental Health (DMH).

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

A review of the claims in question by DMH, concurred in by County Counsel, has concluded that the services were performed and that these claims would have been approved by the State, had they been submitted in a timely fashion. However, due to the difficulties involved in transitioning the FFS billing system from the State to the County, through no fault of the providers, these claims were not submitted timely. Under these circumstances, DMH believes, and County Counsel concurs, that the contractors should not be subject to recoupment of payments

provided to them at that time. Because of the unique circumstances of the transition of the FFS billing system, DMH and County Counsel agree that this is a one-time resolution of claims.

There was a timing issue during the transition period in which the local mental health plan was defining what the covered mental health services would be and at the same time requesting that Electronic Data System (EDS), the DMH claims administrator, make the necessary changes to their system so that system edits were compatible with reimbursable services. Providers submitted claims faster than EDS could change their system and claims were denied. Claims were paid by DMH, to providers; before it was determined that in fact the State had not received the claims for services. Because it was the intent of the Department to pay providers for the services, DMH is seeking approval from the Board to allow the providers of service to retain payments made to them.

The resolution of these claims is the last FFS claiming issue for FY 1998-1999 to be resolved. Other claims arising from that period of transition in systems have been either settled through Board action, through the normal settlement process, or through the Board-authorized Alternative Dispute Resolution process. These claims were not able to be resolved through these processes, and required further review as to appropriateness. DMH has concluded, and County Counsel concurs, that the timeliness issue is not through the fault of the providers, and that, accordingly, Board authorization to resolve this as recommended above should be requested.

Implementation of Strategic Plan Goals

The recommended Board action is consistent with the County's Fourth Goal – "Fiscal Responsibility" within the Countywide Strategic Plan. This Board action will permit DMH to settle claims that resulted from the transition of the FFS Specialty Mental Health Outpatient services system from State to County.

FISCAL IMPACT/FINANCING

There is no net County cost impact. The payments were funded from the FY 1998-1999 State Managed Care Allocation.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Approval of this action will resolve the payment issues given the circumstances related to the FFS billing transition, which is a one-time occurrence.

The Chief Administrative Office, County Counsel and DMH's Program and Financial Services Bureaus have approved the proposed action.

CONTRACTING PROCESS

This Board action will not require any modification to existing or past contracts with providers of specialty mental health services.

IMPACT ON CURRENT SERVICES

There shall be no impact on current services, as these contract providers continue to provide specialty mental health services.
