**APPROVAL OF REQUEST FOR APPROPRIATION ADJUSTMENT  
FOR FISCAL YEAR 2000-2001 SETTLEMENT PAYMENTS TO  
MENTAL HEALTH SERVICE PROVIDERS  
(ALL SUPERVISORIAL DISTRICTS)  
(4 VOTES)**

**IT IS RECOMMENDED THAT YOUR BOARD:**

Approve the Request for Appropriation Adjustment for Fiscal Year (FY) 2003-2004 in the amount of \$5,727,000 (Attachment I). The increase in appropriation will be fully funded by Early and Periodic Screening, Diagnosis and Treatment (EPSDT) State General Funds (SGF) and Federal Financial Participation (FFP) Medi-Cal revenues and will allow the Department of Mental Health (DMH) to reimburse fifty-eight (58) mental health service providers for FY 2000-2001 services. The amount owed to the service providers (Attachment II) was determined through the County settlement process.

**PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS**

As per the DMH Legal Entity Agreements with the mental health service providers, if a post-contract audit determines that the County's liability is more than the amount paid to a service provider for any fiscal year, then the difference shall be paid by the County to the service provider.

DMH has recently completed its FY 2000-2001 Short-Doyle/Medi-Cal (SD/MC) Reconciliation and EPSDT settlement process based on the mental health service providers' submission of certified, true and accurate reimbursement claims. This process has determined that the County owes fifty-eight (58) mental health service providers a total of \$5,727,000 for services delivered in FY 2000-2001.

The Medi-Cal Program is a federal entitlement for persons that are eligible under Title XIX, the Social Security Act. Medical is federally and locally funded.

The EPSDT program is the requirement of the Medicaid (Medi-Cal in California) program to provide comprehensive health care, including mental health for Medi-Cal beneficiaries 0 to 21 years of age. The EPSDT program is funded with federal and eligible local funds. The eligible local match funds for reimbursement of the services addressed in this Board letter are State General Fund (SGF).

The FFP and EPSDT-SGF funding were not included in the Maximum Contract Amount (MCA) for FY 2000-2001. DMH, in its capacity as a pass-through agency, has received pass-through payments from the State and, in turn, is required to disburse such payments to the mental health service providers. There is no requirement for contract amendments because the Board-approved agreement for FY 2000-2001 did not include either the State or federal funding for EPSDT Medi-Cal. This appropriation adjustment increasing Services and Supplies by \$5,727,000 will enable DMH to reimburse FFP and EPSDT-SGF funds, which have been received since the end of FY 2000-2001, to each mental health service provider in the amounts indicated in Attachment II.

### **Implementation of Strategic Plan Goals**

The recommended Board actions are consistent with the County's fourth goal - "Fiscal Responsibility" within the Countywide Strategic Plan. Board approval of this request will enable DMH to make FY 2000-2001 settlement payments to Non-Governmental Agency (NGA) contract agencies as required by Federal law and the Department's Mental Health Service Agreements.

### **FISCAL IMPACT/FINANCING**

There is no increase in net County cost. The \$5,727,000 appropriation requested for the FY 2000-2001 settlement payments will be fully funded from two sources as follows:

- a) FFP Medi-Cal revenues of \$4,098,000 from the FFP Trust Fund. This amount is for FY 2000-2001 services, but was received and deposited in the FFP Trust during FY 2002-2003.
- b) EPSDT SGF funds of \$1,629,000 from the Advances Payable Account. This amount is for FY 2000-2001 services, but was received and deposited in the Advances Payable Account during FY 2002-2003.

### **FACTS AND PROVISIONS/LEGAL REQUIREMENTS**

The Board-approved Mental Health Service Agreement with the mental health service providers has a provision that "For NR (Negotiated Rate) and CR (Cost Reimbursement) services, if the post-contract audit conducted by County, State, and/or federal personnel determines that the amounts paid by County to Contractor for any NR SFC (Service Function Code) units furnished hereunder are less than the allowable pursuant to this Agreement and/or CR services, then the difference shall be paid by County to Contractor, provided that in no event shall County's Maximum Contract Amount for the applicable Fiscal Year, as shown in Subparagraph B (Reimbursement For Initial Period) or C (Reimbursement If Agreement Is Automatically Renewed), be exceeded" (Paragraph 4, Financial Provisions, subparagraph P, Post-Contract Audit Settlement, Section 3).

In accordance with the above referenced provision of the contract, DMH recently completed the FY 2000-2001 SD/MC Reconciliation and EPSDT Settlement process for the mental health service providers. As a result of this settlement process, it was determined that the County owes fifty-eight (58) mental health service providers a total of \$5,727,000 in settlement payments.

### **CONTRACTING PROCESS**

The subject does not apply. This request will enable DMH to comply with the provisions contained in the legal entity agreements with the mental health service providers for FY 2000-2001.


### **IMPACT ON CURRENT SERVICES**
