**APPROVAL OF REQUEST FOR APPROPRIATION ADJUSTMENT FOR
SENATE BILL 90 PAYMENTS TO OUT-OF-STATE AGENCIES
FOR FISCAL YEAR 2002-2003
(ALL SUPERVISORIAL DISTRICTS)
(4 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

Approve the Request for Appropriation Adjustment (Attachment I) for \$3,494,000 for Fiscal Year (FY) 2002-2003. The appropriation increase will provide spending authority to reimburse Out-Of-State Child Placement service providers for contracted services to seriously emotionally disturbed (SED) children/adolescents who reside throughout the County of Los Angeles and are placed in out-of-state education and mental health treatment facilities. The \$3,494,000 is fully funded with prior year Early Periodic Screening and Diagnostic Treatment (EPSDT) – State General Funds (SGF) Settlement Funds.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

In 1984 the California legislature enacted Assembly Bill (AB) 3632 in order to maximize and coordinate the provision of services to handicapped children. The County's intermediary role between contracted service providers and the State for AB 3632 mental health services for severely emotionally disturbed (SED) children is achieved through the Senate Bill (SB) 90 reimbursement process. This process was designed to enable local governments to recover from a net financial injury that results from this State mandated program.

This Board letter deals only with the funding of Out-of-State Child Placement Mental Health Service Agreements. These payments are claimable by the County through the State's SB 90 mandated claim process. Funding for SB 90 claims for contractors located in Los Angeles County will be dealt with separately. This is because the placement contracts are legally different than the in-State SB 90 related contracts in that there are no contractual terms and conditions in the out-of-state contracts pertaining to SB 90 and payment restrictions, and County's current Out-of-State Child Placement Mental Health Service Agreements require payment without consideration of whether the State has paid or not.

In the past your Board has approved three (3) Purchase Orders and nineteen (19) Out-of-State Child Placement Mental Health Service Agreements (see Attachment II), pursuant to Government Code 7576, Chapter 654, Statute of 1996, and Welfare and Institutions Code 300, Sections A through J. The purpose of the agreements is to compensate contractors who provide services to SED children/adolescents who reside throughout the County of Los Angeles and are placed in out-of-state education and mental health treatment facilities because they have either failed in multiple local residential treatment programs or have been refused admission by multiple programs in California. Such out-of-state services are available on a twenty-four (24) hour, seven (7) days per week basis during the term of the agreements.

The Board approved \$20.3 million in appropriation for the AB 3632 program; the entire appropriation was funded with State SB 90 revenues that have failed to materialize. Your Board authorized the Chief Administrative Officer to establish a County General Fund reserve to temporarily backfill the SB 90 funds. Of the \$20.3 million appropriation, \$2.7 million is for these out-of-state placements for FY 2002-2003. However, it is projected that for FY 2002-2003, payments for out-of-state placements will exceed \$6,194,000, and an additional \$3,494,000 appropriation (see Attachment I) is being requested. The original \$2.7 million appropriation was funded as part of the Board approved SB 90 budgeted revenues of \$20,345,000 that will not materialize in FY 2002-2003.

While the \$3,494,000 will be included in the County's FY 2002-2003 SB 90 mandated claim filed with the State, State payment will most likely not be within a twelve (12) month period and temporary alternative funding for the requested additional appropriation as discussed below in the Financing paragraph will be accessed.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the County's Fourth Goal – "Fiscal Responsibility" and Fifth Goal – "Children and Families' Well-Being" within the

Countywide Strategic Plan. DMH will be able to make payments to out-of-state contract providers, which will allow for continued and uninterrupted services rendered to Los Angeles County beneficiaries who reside in out-of-state residential facilities.

FISCAL IMPACT/FINANCING

There is no increase in net County cost (NCC). The appropriation of \$3,494,000 is fully funded with FY 2001-2002 EPSDT State General Funds (SGF).

Since the County serves as the fiscal intermediary between contractors and the State, State SB 90 funds may eventually, under current State law, fund this request of \$3,494,000. However, such SB 90 payment will not occur in FY 2002-2003 or most likely in FY 2003-2004, necessitating DMH to find alternative fund sources other than additional NCC.

The Department has received \$21.7 million of prior FY 2001-2002 EPSDT-SGF revenues (monies have been recorded in DMH's Prior Year Revenue Account, revenue source 9963) that will be recognized in FY 2002-2003. A portion of the \$21.7 Million revenue that is available for other uses will be used to fund the requested appropriation. Because of the twelve (12) month revenue recognition period, the Department did not earlier recognize these funds. They can now be recognized because County collection efforts with the State resulted in receipt of the funds earlier than originally expected from the State.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

DMH has three Purchase Orders and nineteen Out-of-State Child Placement Mental Health Service Agreements to compensate contractors who provide services to SED children/adolescents who reside throughout the County of Los Angeles and are placed in out-of-state education and mental health treatment facilities because they have either failed in multiple local residential treatment programs or have been refused admission by multiple programs in California. DMH originally set aside \$2.7 million of the AB 3632 in its FY 2002-2003 budget to reimburse the three Purchase Orders and nineteen out-of-state contractors; the \$2.7 million has been exhausted for actual rendered services. An additional \$3,494,000 has been projected that will be needed to reimburse the nineteen out-of-state contractors for services delivered in FY 2002-2003 in excess of the original planned budgeted level.

Serving as the intermediary between the contractors and the State, the County does not expect to receive any SB 90 funds from the State before the end of FY 2003-2004 needed to fund the additional \$3,494,000 in claims. Therefore, the Department proposes to use revenues from various settlements, specifically EPSDT-SGF, with the State to fund the additional \$3,494,000 in out-of-state placements costs.

CONTRACTING PROCESS

Per Attachment I, three (3) Purchase Orders and nineteen (19) contractors have existing Out-of-State Child Placement Mental Health Service Agreements with the County.

IMPACT ON CURRENT SERVICES

Your Board approval of this request will enable DMH to make payments to contract providers and will allow for continued and uninterrupted services rendered to Los Angeles County beneficiaries who reside at out-of-state residential facilities by these out-of-state contractors.

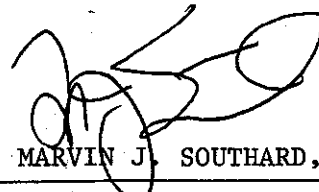
