**APPROVAL OF REQUEST TO SUPERSEDE SIXTY-THREE DEPARTMENT OF
MENTAL HEALTH LEGAL ENTITY AGREEMENTS FOR FISCAL YEARS 2003-2004,
2004-2005 AND 2005-2006
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve the supersession of sixty-three (63) Department of Mental Health (DMH) Legal Entity Agreements, effective upon Board approval, including The Regents of the University of California (Ties for Adoption Program), as listed in the Attachment for Fiscal Years (FY) 2003-2004, 2004-2005, and 2005-2006. The total Maximum Contract Amounts (MCA) for each fiscal year reflects \$278,281,345, \$100,857,474 and \$3,555,465, respectively. The MCA for FYs 2003-2004, 2004-2005 and 2005-2006 may change because of economic factors which may impact the funding that is given to the County by the State and/or Federal government on an annual basis. The MCA for FYs 2004-2005 and 2005-2006 will also change because of anticipated contract renewals. These Agreements will be funded through County General Funds (CGF), Early and Periodic Screening, Diagnosis and Treatment--State General Funds (EPSDT-SGF), Federal and State funds. This action will enable the DMH to ensure implementation of a policy to have uniform terms and conditions for all DMH Legal Entity Agreements which provide for mental health services to severely and persistently mentally ill adults and acutely and severely mentally disturbed children, adolescents and their families.
2. Delegate authority to the Director of Mental Health to prepare, sign and execute amendments to the DMH Legal Entity Agreements and a corresponding Amendment to the Affiliation Agreement with the Regents of the University of

California, Los Angeles, provided that: 1) the County's total payments to a contractor under each Agreement for each fiscal year shall not exceed a change of twenty percent from the applicable revised Maximum Contract Amount; 2) any such increase shall be used to provide additional services or to reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Administrative Officer or his designee is obtained prior to any such Amendment; 5) the parties may by written Amendment mutually agree to reduce programs or services without reference to the twenty percent limitation; and 6) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

There has been an ongoing review of all DMH agreements with Legal Entity providers, and the Chief Administrative Office (CAO) and Auditor-Controller (AC) have recommended that there be uniformity of terms and conditions. DMH and County Counsel concur with this recommendation that the supersession bring in line all existing DMH agreements. In addition, it ensures that agreements are in compliance with the Board's mandated clauses.

Board approval to supersede 63 DMH Legal Entity Agreements will provide for mental health services to severely and persistently mentally ill adults and acutely and severely mentally disturbed children, adolescents and their families.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the County's Seventh Goal – "Health and Mental Health." Superseding these Agreements will allow for increased mental health services to existing mental health clients throughout Los Angeles County.

FISCAL IMPACT/FINANCING

There is no impact on net County cost. These Agreements will start their new fiscal year on July 1, 2003. For FYs 2004-2005 and 2005-2006, funding will be requested during each of the respective budget processes.

The terms and MCAs for each DMH Legal Entity Agreement are shown in the Attachment. CGF, EPSDT-SGF, Federal and State funds provide funding for the 63 DMH Legal Entity Agreements. The total of the MCA's for FY 2003-2004 is

\$278,281,345. The MCAs for FYs 2003-2004, 2004-2005 and 2005-2006 will change because of economic factors which may impact the funding that is given to the County by the State and/or Federal government on an annual basis. The MCA for FYs 2004-2005 and 2005-2006 will also change because of anticipated contract renewals.

The DMH Legal Entity Agreements permit the County to reduce the MCAs or terminate the agreements; whichever is applicable under the terms of the Agreement, if, as a result of the adoption of the County budget, funding in the Agreement is reduced.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The DMH Legal Entity Agreements provide for a broad range of increased services to severely and persistently mentally ill adults, children and adolescents as outlined in California Code of Regulations, Title IX, Chapter 11. These services include acute inpatient care, day treatment services, outpatient programs, rehabilitation services, as well as 24-hour psychiatric emergency services.

Clinical and Administrative staff of DMH are assigned to supervise and administer the Agreements, evaluate the programs to ensure that quality services are being provided to clients and ensure that Agreement provisions and departmental policies are being followed. The Agreement format includes new Board mandated clauses such as: Compliance with Jury Service Program; revised language on Child Support Compliance Program; Health Insurance Portability and Accountability Act; and the "Safely Surrendered Baby Law".

The Chief Administrative Office and DMH's Fiscal and Program Staff have reviewed the proposed actions. All of the Agreements have been approved as to form by County Counsel.

The Attachment (Supersession For Non-Renewal Agreements for FYs 2003-2004, 2004-2005 and 2005-2006) specifies the Contractors, Legal Entity number, Supervisorial District, reimbursement methodology, services provided, Agreement terms and Maximum Contract Amounts per year for each Agreement.

CONTRACTING PROCESS

All of the Contractors identified in this Board Letter have existing Agreements with DMH, which expire on June 30, 2004, June 30, 2005 or June 30, 2006.


IMPACT ON CURRENT SERVICES
