**APPROVAL OF FIRST PHASE OF REDIRECTION AND EXPANSION OF
EARLY AND PERIODIC SCREENING, DIAGNOSIS, AND
TREATMENT-FUNDED PROGRAMS
AND
APPROVAL OF AMENDMENTS TO 18 LEGAL ENTITY AGREEMENTS
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Authorize the Department of Mental Health (DMH) to implement the first phase of the redirection and expansion of the Early and Periodic Screening, Diagnosis and Treatment (EPSDT)-funded programs as set forth herein. Existing EPSDT resources from contractors who are underutilizing their current fiscal year allocation are being redirected to other contractors who will be able to expand their EPSDT services.
2. Approve the proposed redirection and expansion of EPSDT-funded programs, as detailed in Attachment I, for 18 existing Legal Entity Agreements that exceed delegated authority for Fiscal Year (FY) 2002-2003. The redirection and expansion of EPSDT-funded programs are fully funded with EPSDT-State General Funds (SGF) and Federal Financial Participation (FFP) Medi-Cal revenue.
3. Delegate authority to the Director of Mental Health to prepare, sign, and execute amendments to 18 existing Legal Entity Agreements, listed in Attachment I and substantially similar in format to Attachment II, for FY 2002-2003. In the first phase, a total of 73 amendments will be executed that either exceed or fall under delegated authority (Attachment III). Of this total, 18 amendments exceed

delegated authority and are the subject of this Board Letter. The redirection and expansion of EPSDT-funded programs, as shown on Attachment III, result in no additional appropriation increases and are fiscally neutral.

4. Delegate authority to the Director of Mental Health to prepare, sign, and execute future amendments to the DMH Legal Entity Agreements and establish as a new Maximum Contract Amount the aggregate of each original contract and all amendments through and including these amendments, provided that: 1) the County's total payments to each contractor under the Agreement for each fiscal year shall not exceed a change of twenty percent from the applicable revised Maximum Contract Amount; 2) any increase shall be used to provide additional services or to reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Administrative Officer or his designee is obtained prior to any such Amendment; 5) the parties may by written Amendment mutually agree to reduce programs or services without reference to the twenty percent limitation; and 6) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

This Board Letter is the first in a series of several EPSDT expansion plans that DMH is moving forward with for FY 2002-2003. DMH analyzed the current EPSDT allocations of its existing contractors and determined that some contractors were underutilizing their EPSDT resources while others were in need of additional resources for expansion. As a result, DMH completed a comprehensive planning process to address the important future growth of EPSDT-funded mental health services. This was conducted by including as many stakeholders as possible to yield a broad consensus of priorities. This process identified priority programs that are geographically balanced and provide a continuum of mental health services.

Board approval is therefore requested to approve the first phase of the redirection and expansion of EPSDT-funded programs and amending 18 existing Legal Entity Agreements that exceed delegated authority, in order to redirect existing EPSDT resources from DMH contractors underutilizing their current fiscal year allocation. This will allow DMH to implement the expansion of EPSDT-funded mental health services to achieve a more comprehensive and integrated system of care.

Since its inception, the EPSDT Program has allowed DMH to develop a more comprehensive system of care to Medicaid recipients over the past eight years. The

EPSDT Program provides medically necessary services to Medi-Cal eligible beneficiaries under 21 years of age to correct or ameliorate a physical or mental disability or condition, even if the service is not included in the State's Medicaid Plan.

Program expansion will greatly enhance DMH's ability to address specifically needed services in the following priority programs:

- **Children's System of Care (CSOC)**: Family-focused services utilizing a wide range of mental health services for children, ages 0 to 21 with serious emotional disorders, who are at risk of requiring out-of-home placement. The main goals of these services are to support and enhance psychological, emotional and family system functioning, help families effectively manage symptoms of their children's emotional disorder by helping children develop age appropriate social and independent living skills, and increase positive social networks for children and families.
- **Wraparound**: Integrated, family-centered and community-based services designed to stabilize children, who have experienced multiple placements or juvenile facility placements, into long-term and permanent settings with the support of specialized, comprehensive services. Child and family teams are organized for each child and family to facilitate, develop, implement, monitor, and revise uniquely tailored plans of care that include the strategies, services and support to provide "whatever it takes" to address the needs of the child and family in order to maintain the child in a safe, nurturing, permanent community-based setting.
- **Therapeutic Behavioral Services (TBS)**: Mental health services designed for those children/youth who, due to the severity of their behaviors and emotional problems, are at risk of being placed at a higher level of care, are transitioning to a lower level of care (moving from inpatient to community settings), or have had a psychiatric hospitalization within the past two years. TBS can be provided in the home, school, or in the community 24 hours a day, seven days a week. TBS are designed to help stabilize a child/youth in his or her environment and assist the child/youth in becoming increasingly functional in community settings.
- **Day Treatment Intensive and Day Rehabilitation Treatment Programs**: Structured, multi-disciplinary programs that serve as an alternative to hospitalization and more restrictive settings. These programs are designed to improve, maintain, or restore minors' functioning and personal independence.

- **School-Based/School-Linked Programs:** School-based services provided at the school site, and school-linked services offered off-site but within a specified geographical area and/or to a school/school district. Services under this program include case management, individual, group, and crisis intervention. Expansion of school-based services de-stigmatizes mental health needs, allows services to be provided in a child's natural environment, improves access for children and their families, and allows for the integration of mental health services with educational services.
- **Outpatient Programs:** Clinic and community-based mental health services ranging from crisis intervention to an array of treatments, including individual, group, family, medication support, and day treatment interventions. These services are provided across various programs including those that focus on AB3632, substance abuse, child abuse, transitional age youth, foster youth and youth in the juvenile justice system.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the County's Programmatic Goal 5, Children and Families' Well-Being, Strategy 2, within the Countywide Strategic Plan. These augmented services will be integrated into a comprehensive service delivery system through the collaboration of government agencies, private agencies and community-based agencies.

FISCAL IMPACT/FINANCING

The redirection and expansion of EPSDT-funded programs are fully funded with EPSDT-SGF and FFP Medi-Cal revenue for FY 2002-2003. A Request for Appropriation Adjustment is not necessary, as the expansion of EPSDT-funded programs is fully offset by corresponding decreases in allocations to DMH contractors who were not maximizing their current EPSDT resources. This action is fiscally neutral as indicated on Attachment III, and there is no additional net County cost.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The EPSDT Program is Medicaid's comprehensive and preventive child health program for minors under the age of 21. EPSDT was defined as part of the Omnibus Budget Reconciliation Act of 1989 legislation and includes periodic screening, vision, dental and hearing services. In addition, Section 1905(r)(5) of the Social Security Act requires that any medically necessary health care service listed in Section 1905(a) of the Act be

provided to an EPSDT recipient even if the service is not available under the State's Medicaid plan to the rest of the Medicaid population.

As a result of litigation in California, the State of California recognized that it was not in compliance with the Federal statutes and agreed to comply in FY 1994-1995. The Surgeon General's 2000 report estimated that approximately 20 percent of all children and adolescents experience "extreme functional impairment." Therefore, it was estimated that approximately 1.6 million children in California would benefit from mental health intervention. The County of Los Angeles - Department of Mental Health is responsible for approximately one-third of the population.

The redirection of EPSDT resources will ensure that DMH complies with the above Federal mandates, addresses specifically needed services to many children, youth and their families in Los Angeles County, and makes mental health services more readily available and accessible countywide.

The existing and expanded continuum of mental health services (CSOC, Wraparound, TBS, day treatment/day rehabilitation, school-based/school-linked, and outpatient) will provide families throughout Los Angeles County the unconditional commitment to keep children in their communities and prevent placements in more restrictive settings. The integration of mental health services and community-based agency linkage is critical to maintaining children in the community, avoiding placement costs, and improving the functioning of children in their families.

The Amendment (Attachment II) has been approved as to form by County Counsel. The proposed actions have been reviewed by the Chief Administrative Office and DMH's Program and Financial Services administration.

CONTRACTING PROCESS

Upon Board approval, DMH will implement the first phase of the redirection and expansion of EPSDT-funded programs by executing amendments to 18 existing Legal Entity Agreements that exceed delegated authority. The funding amounts for FY 2002-2003 is listed in Attachment I. This expansion promotes the continuity of the network of care throughout Los Angeles County.

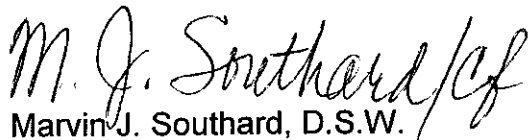
IMPACT ON CURRENT SERVICES

AMENDMENT NO. ____

THIS AMENDMENT is made and entered into this _____ day of _____, 2003, by and between the COUNTY OF LOS ANGELES (hereafter "County") and _____ (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated _____, identified as County Agreement No. DMH-_____, and any subsequent Amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year 2002-2003, County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, the Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Program is funded by State General Funds (SGF) allocated by the State Department of Mental Health and administered by the County of Los Angeles - Department of Mental Health to provide local match dollars to Federal Financial Participation (FFP) Medi-Cal dollars used to fund services for full-scope Medi-Cal beneficiaries under 21 years of age and eligible for EPSDT specialty mental health services that maintain severely emotionally disturbed children and adolescents in the community and/or the least restrictive setting; and

WHEREAS, for Fiscal Year 2002-2003, County and Contractor intend to amend Agreement to revise the EPSDT baseline to the amount of \$ _____ to reflect the EPSDT baseline changes promulgated by the State; and

WHEREAS, for Fiscal Year 2002-2003, County and Contractor intend to amend Agreement to either add or decrease EPSDT funds in the amount of \$ _____ and FFP Medi-Cal funds in the amount of \$ _____ to or from the Maximum Contract Amount for the redirection and expansion of Countywide, community-based children's mental health care services; and

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

1. Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph A (General), Subsection (3) (EPSDT) shall be deleted in its entirety and the following substituted therefor:

"4.A.(3) EPSDT: County agrees to reimburse Contractor during the term of this Agreement for providing EPSDT mental health services/activities over the State established baseline in accordance with Federal and State laws and regulations. Baseline increases imposed by the State will be imposed on the Contractor in like percentages.

EPSDT funds are part of the Maximum Contract Amount(s) of this Agreement and shall be paid by County to Contractor solely in County's capacity as the EPSDT claim intermediary between the Contractor and the State.

Notwithstanding any other provision of this Agreement, in the event that Contractor provides EPSDT services reimbursable under the State's EPSDT mandate claim process, in excess of the Contractor's Fiscal Year 2002-2003 base of \$ _____, Contractor shall be paid by County from EPSDT funds upon receipt from the State. In the event that EPSDT funds are not available to pay EPSDT claims or that State denies any or all of the EPSDT claims submitted by County on behalf of Contractor, Contractor shall indemnify and hold harmless County for any and all liability for payment of any or all of the denied EPSDT claims or for the unavailability of EPSDT funds to pay for EPSDT claims. Contractor shall be solely liable and responsible for all data and information submitted by Contractor to County in support of all claims for EPSDT funds submitted by County as the fiscal intermediary."

2. Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph B (Reimbursement For Initial Period) shall be deleted in its entirety and the following substituted therefor:

"B. Reimbursement For Initial Period: The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) shall not exceed _____ DOLLARS (\$ _____) and shall consist of County, State, and/or Federal (excluding Medicare

Partial Hospitalization services) funds as shown in the applicable Financial Exhibit column(s) which are identified on the Financial Summary. This Maximum Contract Amount includes Cash Flow Advance which is repayable through cash and/or appropriate SFC units and/or actual and allowable costs as authorized by other provisions of this Agreement. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder during the Initial Period."

3. Financial Summary _____ for Fiscal Year 2002-2003 shall be deleted in its entirety and replaced with Financial Summary _____ for Fiscal Year 2002-2003, attached hereto and incorporated herein by reference. All references in Agreement to Financial Summary _____ for Fiscal Year 2002-2003 shall be deemed amended to state "Financial Summary _____ for Fiscal Year 2002-2003."
4. Contractor shall provide services in accordance with the Contractor's Fiscal Year 2002-2003 Negotiation Package for this Agreement and any addenda thereto approved in writing by Director.
5. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
