**APPROVAL OF SB 90 AMENDMENTS TO 45 LEGAL ENTITY
AGREEMENTS FOR FISCAL YEAR 2002-2003
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Approve and delegate authority to the Director of Mental Health to prepare, sign, and execute amendments, substantially similar to Attachment I, to 45 existing Legal Entity Agreements identified on Attachment II for Fiscal Year (FY) 2002-2003. The total increases in the FY 2002-2003 Maximum Contract Amounts of \$6,119,448 are fully funded with budgeted SB 90 revenue. The amendments will enable the Department of Mental Health (DMH) to reimburse contract providers for FY 2002-2003 federally-mandated AB 3632 services to Seriously Emotionally Disturbed (SED) students, up to the FY 2002-2003 budget level, and will be effective upon Board approval.
2. Delegate authority to the Director of Mental Health to prepare, sign, and execute future amendments to these DMH Legal Entity Agreements provided that: 1) the County's total payments to Contractors under each Agreement for each fiscal year shall not exceed a change of twenty percent from the applicable revised Maximum Contract Amount; 2) the Board of Supervisors has appropriated sufficient funds for all changes; 3) approval of County Counsel and the Chief Administrative Officer or his designee is obtained prior to any such Amendment; and 4) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

Board approval of these amendments is necessary because it will enable Contractors identified in Attachment II to be reimbursed for continuing to deliver federally-mandated AB 3632 mental health services to approximately 7,200 eligible pupils in 82 school districts in Los Angeles County.

In the Budget deliberations, the Legislature and Governor allocated only \$1,000 to the State SB 90 claim pool, which in effect sustains the mandate upon counties to provide the AB 3632 services, but assures no reimbursement to counties for services provided during FY 2002-2003.

The present fiscal condition of the State of California is such that the State is apparently unable to provide SB 90 payments for AB 3632 services in a timely manner. The lack of timely payment by the State has led to serious fiscal hardships for contract providers of AB 3632 services during the current FY 2002-2003. Contractors are concerned about the lack of reimbursement for services already delivered during the current fiscal year, and some are experiencing serious cash flow problems and may be unable to pay employees without being reimbursed in a timely manner. DMH has identified \$6,119,448 for the purpose of reimbursing providers in an effort to provide a partial remedy. Working closely with the Chief Administrative Office (CAO) and County Counsel, DMH agrees that it is necessary to reimburse Contractors for these federally-mandated services. To address this problem, the Board has designated \$20.3 million in County General Funds (CGF) for FY 2002-2003 for budgetary uncertainties related to the potential inability of DMH to collect SB 90 revenue from the State.

The existing DMH Legal Entity Agreement boilerplate contains language that Contractors shall be paid by County from SB 90 funds upon receipt from the State, as allowed under the existing contract provision Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph DD (AB 3632 Services Utilizing SB 90 Funds) as follows: "In the event that SB 90 funds are not available to pay SB 90 claims or that State denies any or all of the SB 90 claims submitted by County on behalf of Contractor, Contractor shall indemnify and hold harmless County for any and all liability for payment of any or all of the denied SB 90 claims or for the unavailability of SB 90 funds to pay for SB 90 claims. Contractor shall be solely liable and responsible for all data and information submitted by Contractor to County in support of all claims for SB 90 funds submitted by County as the fiscal intermediary." The agreements set forth in these amendments are made notwithstanding Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph DD (AB 3632 Services Utilizing SB 90 Funds) of the DMH Legal Entity Agreement, which the parties agree will be waived for these purposes, on this one-time only basis, and for this FY 2002-2003, and only to the extent

of the payment by County provided for by this Amendment. Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph DD (AB 3632 Services Utilizing SB 90 Funds) will otherwise apply with full force and effect.

The County and Contractors have agreed upon a partial interim solution to the cash flow problem, on a one-time, non-precedent setting basis only, which will provide some relief to Contractors and allow for the continuance of AB 3632 services, pending fulfillment of the State's payment obligations. Contractor understands that County has devoted a limited fund for this purpose, that payments are being made to other similarly situated providers which exhaust the fund, and that, accordingly, there are no other funds presently available for these purposes.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the County's Goals of Service Excellence, Strategy 2, Organizational Effectiveness, Strategy 3, Fiscal Responsibility, Strategies 1 and 3, and Children and Families' Well-Being, Strategies 1, 2 and 3, within the Countywide Strategic Plan. Approved services will be provided through the collaborative efforts of County and community-based organizations and strengthened through the enhancement of a comprehensive system of care.

FISCAL IMPACT/FINANCING

There is no Net County Cost (NCC) impact if the State pays SB 90 claims within a twelve (12) month period. If the State does not pay within twelve (12) months, there will be a NCC impact on the CGF reserves.

Funding will be from State General Funds (SGF) if the State's FY 2003-2004 Proposed Budget is revised to include SB 90 reimbursements to counties. If SB 90 SGF are not restored to the State's FY 2003-2004 Budget, the funding will be from FY 2002-2003 CGF reserves in the amount of \$20.3 million as approved by the Board of Supervisors earlier in the year for AB 3632 services.

The appropriation for the \$6.1 million in contractor payments for SB 90 services is included in DMH's FY 2002-2003 Adopted Budget. The budgeted funding for the appropriation is SB 90 SGF. However, the Board of Supervisors' approved CGF reserve for the SB 90/AB 3632 program will be utilized should these SB 90 budgeted revenues not be available to DMH within the County's specified a 12 month revenue recognition period.

DMH has provided in prior years and also in FY 2002-2003, \$6,186,869 in CGF as part of the Maximum Contract Amounts for Contractors providing SB 90/AB 3632 reimbursable services. The CGF is for the first \$6,186,869 (also known as the SB 90 Baseline) in rendered AB 3632 services. The DMH Legal Entity Agreement's Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph DD (AB 3632 Services Utilizing SB 90 Funds) identifies the SB 90 Baseline.

While not specifically pertinent to this Board Letter, your Board is advised that DMH's FY 2002-2003 Adopted Budget includes \$20,345,000 in appropriation and SB 90 SGF for the operation of the SB 90/AB 3632 programs. The Adopted Budget's breakdown of the program's revenue is as follows: \$5,337,683 to be retained by DMH for directly operated services, \$6,186,869 to be retained by DMH for contract providers baseline (initially paid by DMH in CGF as part of the existing MCA for contractors providing SB 90/AB 3632 reimbursable services), \$6,119,448 to be paid to contract service providers located within the County of Los Angeles, and \$2,700,000 to be paid to out-of-state contracted service providers.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

In 1984, the California Legislature enacted AB 3632 in order to maximize and coordinate the provision of mental health services to SED children by State and local government agencies. Since the inception of AB 3632, DMH has delivered mental health services to clients through a vast network of directly-operated and community-based provider agencies.

Contractors have expressed serious concern about not being paid for services already delivered. Overall, SB 90 funds are not available to counties to provide timely payments for the federally-mandated services, as the funds are not anticipated to be received from the State within 12 months of the current fiscal year claiming period. Given the urgent circumstances and the critical need to continue federally-mandated services without interruption, the Amendment format (Attachment I) provides a partial interim solution to this cash flow problem, on a one-time only basis, for FY 2002-2003, by allowing County to reimburse Contractors for AB 3632 services already rendered for FY 2002-2003.

While it is the expectation that the State will ultimately reimburse the County and its providers for these services, the parties agree that, given the urgent circumstances, it is vital that services continue to be rendered without interruption. County will accept responsibility for this payment for approved AB 3632 services in the event the State does not pay for them, in the absence of fraud or other wrongdoing on the part of the providers.

The proposed actions have been reviewed and approved by County Counsel, the Chief Administrative Office, and Fiscal and Program Staff. The attached formats have been approved as to form by County Counsel.

CONTRACTING PROCESS

DMH will amend 45 existing Legal Entity Agreements identified in Attachment II to allow Contractors to be reimbursed for continually providing federally-mandated AB 3632 services.


IMPACT ON CURRENT SERVICES

AMENDMENT NO. _____

THIS AMENDMENT is made and entered into this _____ day of _____, 2003, by and between the COUNTY OF LOS ANGELES (hereafter "County") and _____ (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated _____, identified as County Agreement No. _____, and any subsequent amendments (hereafter collectively "Agreement"); and

WHEREAS, for Fiscal Year 2002-2003 only, County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, the present fiscal conditions of the State of California are such that the State is apparently unable to provide its SB 90 payments for AB 3632 services in a timely manner, which circumstances were not anticipated or contemplated by the parties; and

WHEREAS, AB 3632 services derive from a legal mandate and are critical to the recipients thereof; and

WHEREAS, the parties have agreed upon a partial interim solution to this cash flow problem, on a one-time, non-precedent setting basis only, which will

provide some relief to Contractor and allow for the continuance of AB 3632 services, without interruption, pending fulfillment of the State's payment obligations; and

WHEREAS, Contractor understands that County has devoted a limited fund for this purpose, that payments are being made to other similarly situated providers which exhaust the fund, and that, accordingly, there are no other funds presently available for these purposes; and

WHEREAS, in consideration for Contractor's continuing to provide AB 3632 services under this Agreement, notwithstanding the inability of the State to meet its payment obligations in a timely manner, County agrees to pay Contractor \$ _____ as a partial payment for services rendered to date for Fiscal Year 2002-2003 only. It is understood that such services otherwise qualify for payment under the terms and conditions of the Agreement; and

WHEREAS, for Fiscal Year 2002-2003, the revised Maximum Contract Amount will be \$ _____.

NOW THEREFORE, the parties agree to amend the Agreement for Fiscal Year 2002-2003 only, on a one-time, non-precedent setting basis only, as follows:

1. Paragraph 4 (FINANCIAL PROVISIONS), Subparagraph B (Reimbursement For Initial Period) shall be deleted in its entirety and the following substituted therefore:

"B. Reimbursement For Initial Period: The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) shall not exceed _____

_____ DOLLARS (\$ _____)

and shall consist of County, State and/or Federal (excluding Medicare Partial Hospitalization services) funds as shown in the applicable Financial Exhibit column(s) which are identified on the Financial Summary. This Maximum Contract Amount includes Cash Flow Advance which is repayable through cash and/or appropriate SFC units and/or actual and allowable costs as authorized by other provisions of this Agreement. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder during the Initial Period."

2. Financial Summary ___ for Fiscal Year 2002-2003 shall be deleted in its entirety and replaced with Financial Summary ___ for Fiscal Year 2002-2003 attached hereto and incorporated herein by reference. All references in Agreement to Financial Summary ___ for Fiscal Year 2002-2003 shall be deemed amended to state "Financial Summary ___ for Fiscal Year 2002-2003."

3. While it is the expectation that the State will ultimately reimburse Contractor for these services, the parties agree that, given the urgent circumstances and the need for the continuation of the services without interruption, County will accept responsibility for this payment for approved services in the event the State does not pay for them, in the absence of fraud or other wrongdoing on the part of Contractor.
4. The agreements set forth in this Amendment are made notwithstanding Paragraph DD of the Agreement, which the parties agree will be waived for these purposes, on this one-time only basis and for this Fiscal Year 2002-2003 only, and only to the extent of the payment by County provided for by this Amendment. Paragraph DD will otherwise apply with full force and effect.
5. Contractor shall provide services in accordance with the Contractor's Fiscal Year 2002-2003 Negotiation Package for this Agreement and any addenda thereto approved in writing by Director.
6. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
