SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR
FEBRUARY 2017**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of three Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of two new Agreements processed in the month of February 2017 as follows:

1. **Agreement (MH200463) with Bartz-Altadonna Community Health Center** is a newly executed MHSA Master Agreement. The term of this Agreement commenced on February 6, 2017, and shall continue through June 30, 2019.
2. **Agreement (MH9149) with Asana Integrated Medical Group** is a newly executed Medi-Cal Professional Services Agreement. The term of this Agreement commenced on February 2, 2017, and shall continue through June 30, 2017.
