SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR
APRIL 2016**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 39 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of four new Agreements processed in the month of April 2016 as follows:

1. **Agreement (MH9145) with Westside Infant Family Network** is a Medi-Cal Professional Services Agreement. The term of this Agreement commenced on April 19, 2016, and shall continue through June 30, 2017.
2. **Agreement (MH050171) with Corporation for Supportive Housing** is a Consultant Services Agreement. The term of this Agreement commenced on April 28, 2016, and shall continue through June 30, 2017.
3. **Agreement (MH020046) with American Professional Ambulance Corporation** is a Patient/Client Transportation Services Agreement. The term of this Agreement commenced on April 11, 2016, and shall continue through June 30, 2017.
4. **Agreement (MH220047) with Uptown Psychology Group** is a Master Agreement for Project Management Services. The term of this Agreement commenced on April 27, 2016, and shall continue through June 30, 2018.

The following three Amendments (5 through 7) increase/decrease MHSA Integrated Care Program (ICP) Non-MC/MC/Invoice Funded Program funds:

5. **Amendment No. 9 (MH12110) with Barbour and Floyd Medical Associates** for Fiscal Year (FY) 2015-16 increases MHSA ICP MC Funded Program funds in

the amount of \$30,000 and decreases MHSA ICP Non-MC Funded Program funds in the amount of \$15,000. The revised MCA is \$2,873,572.

6. **Amendment No. 5 (MH121277) with Koreatown Youth and Community Center, Inc.,** for FY 2015-16 decreases MHSA ICP Invoice Funded Program funds in the amount of \$4,000 and increases MHSA ICP Non-MC Funded Program funds in the amount of \$4,000. There is no change to the MCA.
7. **Amendment No. 15 (MH121143) with Pacific Asian Counseling Services** for FY 2015-16 decreases MHSA ICP Non-MC Funded Program funds in the amount of \$35,000, increases MHSA ICP Invoice Funded Program funds in the amount of \$35,000, and increases MHSA ICP MC Funded Program funds in the amount of \$36,000. The revised MCA is \$4,326,586.

The following six Amendments (8 through 13) add/change/delete business address, name, and Service Delivery Site. There is no change to the MCAs:

8. **Amendment No. 15 (MH121149) with Providence Community Services, LLC,** for FY 2015-16 changes its business name from Providence Community Services, LLC, to Pathways Community Services, LLC.

10. **Amendment No. 10 (MH121246) with Amanecer Community Counseling Services, Inc.,** for FY 2015-16 changes business address by deleting suite numbers 100, 305, 406, and 500 under PN 7104 and adds suite number 300 (3rd Floor).
11. **Amendment No. 4 (DMH01151) with Plaza Community Center, Inc.,** for FY 2015-16 changes its business address from 648 South Indiana Street, Los Angeles, CA 90023, to 4018 City Terrace Drive, Los Angeles, CA 90063.

15. **Amendment No. 11 (MH121246) with Amanecer Community Counseling Services, Inc.,** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$4,909. The revised MCA is \$10,194,901.
16. **Amendment No. 10 (MH121266) with Foothill Family Service** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$14,683. The revised MCA is \$14,043,375.
17. **Amendment No. 9 (MH121264) with Five Acres – The Boys' & Girls' Aid Society of Los Angeles County** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$5,134. The revised MCA is \$17,810,869.
18. **Amendment No. 3 (MH121295) with Stirling Academy, Inc.,** for FY 2015-16 decreases MHSA PEI MC Funded Program funds in the amount of \$560,000. The revised MCA is \$2,591,640.
19. **Amendment No. 13 (MH121160) with SunBridge Harbor View Rehabilitation Center** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$12,625. The revised MCA is \$5,707,121.
20. **Amendment No. 4 (MH121295) with Stirling Academy, Inc.,** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$7,075. The revised MCA is \$2,598,715.
21. **Amendment No. 10 (MH121166) with The Institute for the Redesign of Learning** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$3,500. The revised MCA is \$11,474,677.
22. **Amendment No. 8 (MH121106) with The Regents of the University of California** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$1,510. The revised MCA is \$1,869,267.

23. **Amendment No. 8 (MH121280) with Los Angeles Child Guidance Clinic** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$28,590. The revised MCA is \$19,756,827.
24. **Amendment No. 17 (MH121149) with Pathways Community Services LLC,** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$1,140. The revised MCA is \$7,565,153.
25. **Amendment No. 8 (MH121286) with Para Los Ninos** for FY 2015-16 increases MHSA PEI Invoice Funded Program funds in the amount of \$6,072. The revised MCA is \$2,436,170.

The following one Amendment (26) increases MHSA Full Service Partnership (FSP) Wraparound MC Funded Program funds and decreases MHSA FSP MC Funded Program funds. There is no change to the MCA:

26. **Amendment No. 9 (MH121244) with Alma Family Services** for FY 2015-16 increases MHSA FSP Wraparound MC Funded Program funds in the amount of \$25,732 and decreases MHSA FSP MC Funded Program funds in the amount of \$25,732.

The following six Amendments (27 through 32) increase/decrease Specialized Foster Care (SFC) Wraparound MC Funded Program funds and/or increase SFC Enhanced Mental Health Services MC Funded Program funds:

27. **Amendment No. 13 (MH121269) with Hathaway-Sycamores Child and Family Services** for FY 2015-16 increases SFC Wraparound MC Funded Program funds in the amount of \$495,554. The revised MCA is \$44,375,294.
28. **Amendment No. 8 (MH121264) with Five Acres – The Boys' & Girls' Aid Society of Los Angeles County** for FY 2015-16 increases SFC Wraparound MC Funded Program funds in the amount of \$349,192. The revised MCA is \$17,805,735.
29. **Amendment No. 7 (MH121123) with El Centro Del Pueblo, Inc.,** for FY 2015-16 decreases SFC Wraparound MC Funded Program funds in the amount of \$1,000,000. The revised MCA is \$1,417,624.
30. **Amendment No. 4 (MH121258) with Drew Child Development Corporation, Inc.,** for FY 2015-16 decreases SFC Wraparound MC Funded Program funds in the amount of \$529,000. The revised MCA is \$2,560,613.

31. **Amendment No. 14 (MH121272) with Hillside**s for FY 2015-16 increases SFC Wraparound MC Funded Program funds in the amount of \$403,663. The revised MCA is \$17,282,664.
32. **Amendment No. 13 (MH121193) with Exodus Foundation** for FY 2015-16 increases SFC Enhanced Mental Health Services MC Funded Program funds in the amount of \$567,400. The revised MCA is \$8,983,759.

The following two Amendment (33 and 34) increase First 5 MC/Non-MC Funded Program funds for Parent-Child Interaction Therapy Training:

33. **Amendment No. 7 (MH121261) with ENKI Health and Research Systems, Inc.**, for FY 2015-16 increases First 5 MC Funded Program funds in the amount of \$42,000. The revised MCA is \$33,807,517.
34. **Amendment No. 29 (MH121158) with Star View Behavioral Health, Inc.**, for FY 2015-16 increases First 5 Non-MC Funded Program funds in the amount of \$10,000 and increases First 5 MC Funded Program funds in the amount of \$28,000. The revised MCA is \$41,128,585.

The following one Amendment (35) increases/decreases MHSA Urgent Care Center (UCC) MC/Non-MC Funded Program funds and increases Post Release Community Supervision (PRCS) Invoice Funded Program funds:

35. **Amendment No. 12 (MH121193) with Exodus Foundation** for FY 2015-16 decreases MHSA UCC Non-MC Funded Program funds in the amount of \$1,137,000, increases MHSA UCC MC Funded Program funds in the amount of \$1,999,334, and increases PRCS Invoice Funded Program funds in the amount of \$21,513. The revised MCA is \$8,416,359.

The following two Amendment (36 and 37) increase/decrease MHSA Wellness Center Non-MC/Invoice Funded Program funds:

36. **Amendment No. 4 (MH121125) with Emotional Health Association dba SHARE! The Self-Help And Recovery Exchange** for FY 2014-15 decreases MHSA Wellness Center Non-MC Funded Program funds in the amount of \$12,014. The revised MCA is \$2,360,932.
37. **Amendment No. 4 (MH121233) with Westside Center for Independent Living, Inc.**, for FY 2014-15 decreases MHSA Wellness Center Non-MC Funded Program funds in the amount of \$14,658 and increases MHSA Wellness Center Invoice Funded Program funds in the amount of \$14,658. There is no change to the MCA.

The following one Amendment (38) increases/decreases Homeless Services Non-MC/Invoice Funded Program funds:

38. **Amendment No. 11 (MH121157) with St. Joseph Center** for FY 2015-16 decreases Homeless Services Non-MC Funded Program funds in the amount of \$20,000 and increases Homeless Services Invoice Funded Program funds in the amount of \$20,000. There is no change to the MCA.

The following one Amendment (39) increases/decreases MHSA Planning, Outreach, & Engagement (POE) Invoice/Non-MC Funded Program Funds:

39. **Amendment No. 1 (MH121306) with Westside Center for Independent Living, Inc.,** for FY 2015-16 decreases MHSA POE Invoice Funded Program funds in the amount of \$26,000 and increases MHSA POE Non-MC Funded Program funds in the amount of \$26,000. There is no change to the MCA.

The following one Amendment (40) increases Hardware Categorical funding and decreases Electronic Health Record (EHR) Maintenance Project funds. There is no change to the MCA:

40. **Amendment No. 2 (MH100724) with Foothill Family Service** for FY 2015-16 adds Hardware category funding in the amount of \$33,658 and decreases EHR Maintenance Project funds from \$100,094 to \$66,436, representing a project budget shift of \$33,658.

The following one Amendment (41) revises Exhibit A – Statement of Work (SOW) and Exhibit B – Fee Schedule (FS), decreases PEI Program Implementation costs, and increases/decreases Deliverables 1 – 4. There is no change to the MCA:

41. **Amendment No. 2 (MH050154) with CASA of Los Angeles** for FY 2015-16 revises Exhibit A – SOW and Exhibit B – FS; decreases PEI Program Implementation cost funds in the amount of \$200; increases Deliverable 1 funds in the amount of \$17,500; increases Deliverable 2 funds in the amount of \$42,000; decreases Deliverable 3 funds in the amount of \$32,800; and decreases Deliverable 4 funds in the amount of \$26,500.

The following one Amendment (42) is a funding-related Amendment with two or more actions:

42. **Amendment No. 21 (MH121293) with Special Service for Groups** for FY 2015-16 increases PRCS MC Funded Program funds in the amount of \$998,000, increases PRCS Invoice Funded Program funds in the amount of \$40,000, increases DHS EPIC MC Funded Program funds in the amount of \$70,000,

increases County General Funds (CGF) Institution for Mental Disease (IMD) Step-Down MC Funded Program funds in the amount of \$1,000,000, increases CGF IMD Step-Down Invoice Funded Program funds in the amount of \$100,000, decreases PRCS Non-MC Funded Program funds in the amount of \$1,038,000, and increases CGF IMD Step-Down Non-MC Funded Program funds in the amount of \$1,100,000. The revised MCA is \$42,784,832.

The following one Amendment (43) revises the Contractor's Obligation as a Business Associate under the Health Insurance Portability and Accountability Act (HIPAA). There is no change to the MCA:

- 43. Amendment No. 1 (MH220047) with Uptown Psychology Group** for FYs 2015-16, 2016-17, and 2017-18 revises the Contractor's Obligation as a Business Associate under the HIPAA of 1996 to incorporate additional privacy and security requirements applicable to business associates.
