SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR MARCH 2016**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 126 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of three new Agreements processed in the month of March 2016 as follows:

1. **Agreement (MH200448) with Living Advantage, Inc.,** is a newly executed MHSA Master Agreement. The term of this Agreement commenced on March 11, 2016, and shall continue through June 30, 2016.
