SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR
DECEMBER 2015**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 115 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, Unique Agreements, Consultant Services Agreements, and execution of one new Agreement processed in the month of December 2015 as follows:
