SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR NOVEMBER 2015**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 163 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of nine new Agreements processed in the month of November 2015 as follows:

1. **Agreement (MH040109) with First To Serve, Inc.**, is a new Basic Living Support Service Agreement which shall commence on November 16, 2015, and end June 30, 2016. There is no Maximum Contract Amount (MCA).
2. **Agreement (MH060097) with The Regents of the University of California** on behalf of Resnick Neuropsychiatric Hospital at UCLA. The period of this Agreement shall commence on December 9, 2015, and shall continue in full force and effect through June 30, 2016.

The following two Agreements (3 and 4) are executed Master Agreements for Project Management Services for Fiscal Years (FYs) 2015-16 through 2017-18. There is no change to the MCA.

3. **Agreement (MH220030) with Interpersonal Psychotherapy Institute, LLC.** The period of this Agreement shall commence on November 12, 2015, and shall continue in full force and effect through June 30, 2018.
4. **Agreement (MH220029) with Cornell University.** The period of this Agreement shall commence on November 30, 2015, and shall continue in full force and effect through June 30, 2018.

The following three Agreements (5 through 7) were established for the Specialized Contract-Master Agreements for the MHSA for FY 2015-16.

5. **Agreement (MH200445) with Recovery Innovations, Inc.** The period of this Agreement shall commence on September 17, 2015, and shall continue in full force and effect through June 30, 2016.
6. **Agreement (MH200447) with Pathways to Your Future.** The period of this Agreement shall commence on November 13, 2015, and shall continue in full force and effect through June 30, 2016.
7. **Agreement (MH200446) with Affordable Living for the Aging.** The period of this Agreement shall commence on November 2, 2015, and shall continue in full force and effect through June 30, 2016.

The following two Agreements (8 and 9) were established for Medi-Cal Professional Services.

8. **Agreement (MH29837) with Gandhi Devinder, M.D.,** as an individual provider. The initial period of this Agreement shall commence on December 8, 2015, and shall continue in full force and effect through June 30, 2017.
9. **Agreement (MH29838) with Kelly Walker, LCSW,** as an individual provider. The initial period of this Agreement shall commence on December 21, 2015, and shall continue in full force and effect through June 30, 2017.

The following 16 Amendments (10 through 25) are funding-related Amendments with one or more action:

For FY 2015-16 and any subsequent fiscal years, this amendment decreases Juvenile Justice Crime Prevention Act (JJCPA) Program Non-MC Funded Program funds by \$75,000. The revised MCA is \$8,381,332.
12. **Amendment No. 2 (MH010106) with The Regents of the University of California** revises Agreement language under Section 7.4 (Timing of Invoices), Subparagraph 7.4.1, to include Subparagraphs 7.4.2, 7.4.2.1, 7.4.2.2., and 7.4.2.3. Funding for residents is added in the amount of \$213,750 under the Graduate Medical Services. For FYs 2015-16 and 2016-17 only, the revised MCAs are \$834,629 and \$834,629, respectively.
13. **Amendment No. 3 (MH010106) with The Regents of the University of California** adds \$50,000 for the Annual Statewide Integrated Care Conference that will reinforce those best practices and competencies gained through Co-Occurring Disorders (COD) System-Wide Training Project, related to Addendum A, Subsection A2.1.c (Annual Statewide Integrated Care Conference). The total funding for Addendum A, Subsection A3.2, is \$318,190. For FYs 2015-16, 2016-17, 2017-18, and 2018-19, the MCAs are \$884,629, \$884,629, \$670,879, and \$670,879, respectively.
14. **Amendment No. 10 (MH121293) with Special Service for Groups** for FY 2015-16 Comprehensive Adult Re-Entry (CARE) Program 2nd Chance Non-MC funds are added in the amount of \$431,162 and CARE Program 2nd Chance Invoice funds are added in the amount of \$25,536. For FY 2016-17, Care Program 2nd Chance Non-MC funds are added in the amount of \$58,658 and CARE Program 2nd Chance Invoice funds are added in the amount of \$6,384. For FY 2015-16 the MCA is increased by \$456,698 and the revised MCA is \$40,530,501. For FY 2016-17 the MCA is increased by \$65,042 and the revised MCA is \$39,228,542.
15. **Amendment No. 1 (MH190116) with College Hospital – Cerritos** for FY 2015-16 changes number on Financial Summary Subprogram Schedule from Attachment IV to Attachment III. Attachment IV was inadvertently incorporated. Revised Financial Summary (Attachment II) and Financial Summary Subprogram Schedule (Attachment III), which provides rows for certain Funded Programs to allow for invoice billing, will be included. The MCA is decreased by \$55,414, and the revised MCA is \$1,366,400.

16. **Amendment No. 3 (MH121233) with Westside Center for Independent Living** for FY 2014-15 only, MHSA Planning, Outreach, and Engagement (POE) Invoice Funded Program funds are decreased in the amount of \$26,000. MHSA POE Non-MC Funded Program funds are increased in the amount of \$26,000. This is a technical correction Amendment due to an oversight on the part of the Contractor. There is no change to the MCA.
17. **Amendment No. 9 (MH121107) with Alcott Center for Mental Health Services** for FY 2015-16 and any subsequent fiscal years during the term of this agreement shifts funding in the amount of \$65,000 from MHSA Urgent Care Center Non-MC to MHSA Urgent Care Center Non Medi-Cal Invoice. The MCA for FY 2015-16 will remain the same at \$1,918,930.
18. **Amendment No. 1 (MH110002) with Primex Clinical Laboratories, Inc.,** amends Agreement language due to County's implementation of an electronic laboratory test request interface with Integrated Behavioral Health Information System.
