SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS FOR OCTOBER 2015**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 59 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of 1 new Agreement processed in the month of October 2015 as follows:
