SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 197 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 189 new Agreements processed in the month of June 2014 as follows:

1. **Agreement (MH010106) with The Regents of the University of California** was executed under the Department of Mental Health (DMH) Affiliation Agreement. The term of the Agreement is from July 1, 2014, through June 30, 2015.
2. **Agreement (MH040108) with Women For Sobriety Center** was executed under the Master Agreement for Basic Living Support Services. The term of the Agreement is from July 1, 2014, through June 30, 2016.
3. **Agreement (MH050149) with California Mental Health Directors Association** was executed under the Consultant Services Agreement. The term of the Agreement is from July 1, 2014, through June 30, 2015.
4. **Amendment No. 8 (MH120280) with Vista Del Mar Child and Family Services** increases Federal Financial Participation (FFP) funds in the amount of \$578,069 and Early and Periodic Screening, Diagnosis, and Treatment Program (EPSDT), State General Fund (SGF) funds in the amount of \$490,485 for Fiscal Year (FY) 2007-08 only. The revised Maximum Contract Amount (MCA) is \$9,287,925.
5. **Amendment No. 3 (MH121034) with The Whole Child-Mental Health & Housing Services** adds a new Medi-Cal/Short-Doyle Provider Number (PN) To Be Assigned (TBA), located at 9255 S. Pioneer Boulevard, Santa Fe Springs, CA 90670; and service delivery site at 12225 Beverly Boulevard, Whittier, CA 90601.

The services provided are: Targeted Case Management Services (TCMS), Mode 15, Service Function Codes (SFCs) 01-09; Mental Health Services (MHS), Mode 15, SFCs 10-19/30-59; Crisis Intervention, Mode 15, SFCs 70-79; Mental Health Promotion, Mode 45, SFCs 10-19; and Community Client Services, Mode 45, SFCs 20-29. There is no change to the MCA.
