SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 36 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal (MC) Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of three new Agreements processed in the month of March 2015 as follows:

1. **Agreement (MH050158) with El Rancho Unified School District** is an MHSA Prevention and Early Intervention (PEI) Consultant Service Agreement for Fiscal Years (FY) 2014-15 and 2015-16. Maximum Contract Amount (MCA) is \$100,000 per year.
2. **Agreement (MH150326) with GAA Pharmacy, Inc.**, is a new Pharmacy Contract for FY 2014-15.
3. **Agreement (MH200439) with Westside Infant-Family Network** is a MHSA agreement for FYs 2014-15 and 2015-16.
4. **Amendment No. 6 (MH121017) with Five Acres-The Boys' & Girls' Aid Society of Los Angeles County** shifts \$45,000 from Specialized Foster Care Wraparound Medi-Cal (MC) Funded Program to Specialized Foster Care Multi-Disciplinary Assessment Team (MAT) MC Funded Program. There is no change to the MCA.
5. **Amendment No. 4 (MH121107) with Alcott Center for Mental Health Services** increases MCA by \$14,583 for FY 2014-15. The revised MCA is \$2,119,748.
6. **Amendment No. 7 (MH121139) with Mental Health America of Los Angeles** shifts \$1,000,000 Comprehensive System of Care-Substance Abuse and Mental Health Service Administration (SAMHSA) Non-MC Funded Program funds to

SAMHSA Invoice Funded Program funds for FYs 2014-15, 2015-16, and 2016-17, respectively. There is no change to the MCA.

7. **Amendment No. 6 (MH121146) with Penny Lane Centers** increases PEI school based program funds by \$140,880 for FYs 2014-15, 2015-16, and 2016-17. The revised MCAs are \$27,064,251, \$23,089,598, and \$23,089,598, respectively.
8. **Amendment No. 7 (MH121146) with Penny Lane Centers** increases Field Capable Clinical Services (FCCS) program funds by \$158,560, \$410,831, and \$410,831 for FYs 2014-15, 2015-16, and 2016-17. The revised MCAs are \$27,222,811, \$23,500,428, and \$23,500,429, respectively.
9. **Amendment No. 4 (MH121163) with Tessie Cleveland Community Services Corporation** decreases MHSA Full Service Partnership Invoice Funded Program funds in the amount of \$78,500 and increases MHSA FCCS MC Funded Program funds in the amount of \$157,000 for FYs 2014-15, 2015-16, and 2016-17. The revised MCA is \$10,668,789.
10. **Amendment No. 1 (MH121174) with AIDS Project Los Angeles** delegates its duties and assigns the rights from contractor AIDS Project Los Angeles (APLA) to APLA Health & Wellness, assignor's sister company. There is no change to the MCA.
11. **Amendment No. 3 (MH12180) with California Institute of Health and Social Services, Inc., dba Alafia Mental Health Institute** increases the MCA in the amount of \$140,880 for FY 2014-15. The revised MCA is \$2,806,663.
12. **Amendment No. 3 (MH121214) with Olive Crest** decreases Specialized Foster Care (SFC) and Treatment Foster Care (TFC) MC Funded Program funds in the amount of \$120,000. Increases SFC Enhanced Mental Health Services MC Funded Program funds in the amount of \$120,000 for FY 2014-15. There is no change to the MCA.
13. **Amendment No. 12 (MH121215) with Pacific Clinics** decreases MHSA Family Support Services Non-MC Funded Program funds in the amount of \$20,000 and increases MHSA Family Support Services Invoice Funded Program funds in the amount of \$20,000 for FY 2014-15. There is no change to the MCA.
14. **Amendment No. 2 (MH190117) with Women Shelter of Long Beach** intends to amend Agreement to revise Exhibit A "Statement of Work" and Exhibit B "Fee

Schedule” to increase the nightly rate from \$85.00 to \$96.00 for FYs 2014-15, 2015-16, and 2016-17.

15. **Amendment No. 1 (MH200439) with Westside Infant Family Network** amends agreement to include provision regarding a Contractor's Obligation as a Business Associate under the Health Insurance Portability and Accountability Act (HIPAA).

***The following two Amendments (16 and 17) shift SFC TFC MC funds to SFC Enhanced Mental Health Services MC for FY 2014-15. There is no change to the MCA:***

16. **Amendment No. 7 (MH121195) with Five Acres–The Boys' & Girls' Aid Society of Los Angeles County.**
17. **Amendment No. 4 (MH121115) with ChildNet Youth and Family Services Inc.**

***The following two Amendments (18 and 19) are technical corrections:***

18. **Amendment No. 3 (MH121201) with HealthView, Inc., dba Harbor View House** is a technical correction to correct the amount of associated local match funds to the MHSA Wellness Center MC funds from \$86,638 to \$61,180. There is no change to the MCA.
19. **Amendment No. 4 (MH121193) with Exodus Foundation** is a technical adjustment which corrects a typographical error “\$8,228,539” in Amendment #3 pertaining to the FY 2014-15. The revised MCA is \$8,601,680.

***The following two Amendments (20 and 21) add funds to the MCA for Special Service for Groups (SSG):***

20. **Amendment No. 6 (MH121223) with Special Service for Groups** adds \$143,000 to the MCA for SSG. The revised MCA is \$42,848,537.
21. **Amendment No. 7 (MH121223) with Special Service for Groups** adds \$40,000 to the MCA for SSG. The revised MCA is \$42,888,537.

***The following three Amendments (22 through 24) increase MHSA FCCS MC/Non-MC Funded Program funds for FY 2014-15:***

22. **Amendment No. 7 (MH121187) with Didi Hirsch Psychiatric Service** increases MHSA (FCCS) Non-MC Funded Program funds in the amount of

\$2,083 and increases MHSA FCCS Funded program funds by \$12,500. The revised MCA is \$34,416,631.

23. **Amendment No. 9 (MH121200) with Hathaway-Sycamores Child and Family Services** increases MHSA FCCS Non-MC Funded Program funds in the amount of \$17,247; increases MHSA FCCS Invoice Funded Program funds by \$5,749; and increases MHSA FCCS MC Funded Program funds in the amount of \$229,963. The revised MCA is \$41,194,909.
24. **Amendment No. 6 (MH121232) with Vista del Mar Child and Family Services** increases MHSA FCCS MC Funded Program funds in the amount of \$61,601; increases MHSA Non-MC Funded Program funds in the amount of \$4,620; and increases MHSA FCCS Invoice Funded Program funds in the amount of \$1,540. The revised MCA is \$10,942,116.

***The following three Amendments (25 through 27) increase MHSA PEI MC Funded Program funds and DMH MC Funded Program funds for FYs 2014-15, 2015-16, and 2016-17:***

25. **Amendment No. 5 (MH121114) with Child and Family Guidance Center** increases MHSA PEI MC Funded Program funds in the amount of \$128,328, \$128,328, and \$128,328 and DMH MC Funded Program funds in the amount of \$12,552, \$12,552, and \$12,552. The revised MCAs are \$25,246,308, \$24,976,308, and \$24,976,308, respectively.
26. **Amendment No. 5 (MH121118) with Counseling and Research Associates** increases MHSA PEI MC Funded Program funds in the amount of \$128,328, \$128,328, and \$128,328 and DMH MC Funded Program funds in the amount of \$12,552, \$12,552, and \$12,552. The revised MCAs are \$11,791,766, \$11,562,767, and \$11,562,767, respectively.
27. **Amendment No. 4 (MH121142) with Optimist Boys' Homes and Ranch, Inc.,** increases MHSA PEI MC Funded Program funds in the amount of \$128,328, \$128,328, and \$128,328 and DMH MC Funded Program funds in the amount of \$12,552, \$12,552, and \$12,552. The revised MCAs are \$6,868,009, \$6,572,279, and \$6,572,279, respectively.

***The following four Amendments (28 through 31) increase Fee-For-Service (FFS) MC acute psychiatric inpatient day rate:***

28. **Amendment No. 1 (MH060037) with Brotman Medical Center, Inc.,** increases FFS MC acute psychiatric inpatient day rate from \$523 to \$600.

29. **Amendment No. 1 (MH060053) with Providence Health & Services-Southern California** increases FFS MC acute psychiatric inpatient day rate from \$523 to \$600.
30. **Amendment No. 3 (MH060057) with The Regents of the University of California** increases FFS MC acute psychiatric inpatient day rate from \$627 to \$720.
31. **Amendment No. 1 (MH060065) with USC Verdugo Hills Hospital, LLC,** increases FFS MC acute psychiatric inpatient day rate from \$523 to \$600.
