SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 19 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of six new Agreements processed in the month of March 2013, as follows:

1. **Amendment No. 4 (MH120932) with The Village Family Services** adds a new Service Delivery Site located at 6801 Coldwater Canyon Avenue, 1E, North Hollywood, CA 91605, Provider No. (PN) To Be Designated (TBD).
2. **Amendment No. 2 (MH120929) with The Children's Center of the Antelope Valley** decreases Department of Mental Health (DMH) Medi-Cal/Healthy Families (HF) in the amount of \$62,762; decreases Prevention and Early Intervention Programs (PEI) Non Medi-Cal/Non HF in the amount of \$25,118; and decreases PEI Medi-Cal/HF in the amount of \$641,642. The revised Maximum Contract Amount (MCA) is \$1,109,950.

The following two Amendments (3 and 4) to LE and Specialized Agreements increase/decrease Institutions for Mental Disease (IMD) Step-Down Programs for Non Medi-Cal/Non HF and Medi-Cal/HF:

3. **Amendment No. 10 (MH120886) with Special Service for Groups** increases funds for five additional beds under the IMD; omits Attachment VI; adds Exhibit 28; increases IMD Non Medi-Cal/Non HF in the amount of \$111,071; and increases IMD Medi-Cal/HF in the amount of \$306,880. The revised MCA is \$36,030,074.

4. **Amendment No. 12 (MH120965) with Telecare Corporation** increases funds for six additional beds under IMD, Non Medi-Cal/Non HF, in the amount of \$133,174, and increases IMD Medi-Cal/HF in the amount of \$367,920. The revised MCA is \$13,810,305.

The following three Agreements (5 through 7) are Specialized Agreements being executed under the Mental Health Services Act (MHSA) Master Agreement:

5. **Agreement (MH200390) with African Communities Public Health Coalition** the term of the Agreement is from March 14, 2013, through June 30, 2016.
6. **Agreement (MH200392) with SISTAHFRIENDS** the term of the Agreement is from March 14, 2013, through June 30, 2016.
7. **Agreement (MH200393) with New Economics for Women** the term of the Agreement is from March 25, 2013, through June 30, 2016.

The following three Agreements (8 through 10) are being executed under the Technological Needs Project Funding Agreement:

8. **Agreement (MH100527) with Exodus Recovery, Inc.**, the term of this Agreement is from March 18, 2013, through June 30, 2016.
9. **Agreement (MH101228) with Pasadena Unified School District** the term of this Agreement is from March 25, 2013, through June 30, 2016.
10. **Agreement (MH101285) with Dignity Health dba California Hospital Medical Center** the term of this Agreement is from March 1, 2013, through June 30, 2016.

The following three Amendments (11 through 13) expand Family Support Services (FSS) Exhibit revised to provide Child Full Service Partnership (FSP), and FSS, as part of the implemented pilot program FSS Enhanced Respite Care Program, for short-term relief to caregivers who provide services to clients with Severe Emotional Disturbance (SED). There is no change to the MCA:

11. **Amendment No. 4 (MH120901) with Child and Family Guidance Center**
12. **Amendment No. 2 (MH120904) with David & Margaret Home, Inc.**

13. **Amendment No. 3 (MH120963) with SunBridge Harbor View Rehabilitation Center dba Harbor View Adolescent Center, a wholly-owned subsidiary of Regency Health Services, Inc.; SunBridge Healthcare, LLC; Sun Healthcare Group, Inc.; GHC Holdings II, LLC; Genesis HealthCare, LLC**

The following four Amendments (14 through 17) to LE and Specialized Agreements increase/decrease and/or add MHSA FSP and Field Capable Clinical Services (FCCS) for Non Medi-Cal/Non HF and Non Medi-Cal/HF funds:

14. **Amendment No. 13 (MH120876) with Pacific Clinics** increases MHSA FSP Non Medi-Cal/Non HF in the amount of \$59,879, and increases FSP Medi-Cal/HF in the amount of \$120,000. The revised MCAs for Fiscal Years (FYs) 2012-13, 2013-14, and 2014-15, will be \$78,893,128, \$77,865,136, and \$77,865,136, respectively.
15. **Amendment No. 2 (MH120882) with Saint John's Health Center** decreases MHSA FCCS Non Medi-Cal/Non HF in the amount of \$5,000, and increases MHSA FCCS Medi-Cal/HF in the amount of \$10,000, for Medi-Cal child. The revised MCA for FYs 2012-13, 2013-14, and 2014-15 will be \$2,865,714.
16. **Amendment No. 7 (MH120922) with PROTOTYPES, Centers for Innovation in Health Mental Health, Mental Health and Social Services** adds the MHSA FCCS Non Medi-Cal/Non HF in the amount of \$110,000, and adds MHSA Wellness Centers Non Medi-Cal/Non HF in the amount of \$40,000, for Healthy Way L.A. (HWLA) Tier I for Low Income Health Program (LIHP), under the 1115 Waiver Demonstration Project. The revised MCA is \$7,811,605.
17. **Amendment No. 10 (MH120965) with Telecare Corporation** increases MHSA FSP Non Medi-Cal/HF in the amount of \$24,269, and increases FSP Medi-Cal/HF in the amount of \$72,000. The revised MCAs for FYs 2012-13 and 2013-14 are \$13,309,211 and \$11,318,173, respectively.

The following eight Administrative Amendments (18 through 25) to the LE Agreements modify the current Financial Summary Subprogram Schedule (Attachment IV) and Fee-For-Service Group Agreement Additional Group Provider. There is no change in the MCA:
