SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 48 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of four new Agreements processed in the month of March 2014 as follows:

1. **Agreement (MH040105) with Testimonial Community Love Center** was executed under the MHSA Master Agreement. The term of the Agreement is from March 20, 2014, through June 30, 2016.
2. **Agreement (MH050146) with Constant and Associates, Inc.**, was executed under the Consultant Services Agreement. The term of the Agreement is from March 24, 2014, through June 30, 2016.
3. **Agreement (MH9044) with Pacific Resources Psychological Group, Inc.**, was executed under the Medi-Cal Professional Services Agreement. The term of the Agreement is from March 18, 2014, through June 30, 2014.
4. **Agreement (MH100695) with Eldorado Community Service Center** was executed under the Technological Needs Projects Agreement. The term of the Agreement is from March 5, 2014, through June 30, 2016.
5. **Amendment No. 3 (MH120176) with Southern California Health & Rehabilitation Program (SCHARP) formerly known as South Central Health and Rehabilitation Program (SCHARP)** changes Contractor's name from South Central Health and Rehabilitation Program (SCHARP) to Southern California Health & Rehabilitation Program (SCHARP).

6. **Amendment No. 3 (MH190065) with Trilogy Integrated Resources, LLC**, extends the term of the Agreement for 12 additional months beginning July 1, 2014, through June 30, 2015, on a month-to-month basis, and the total monthly expenditures shall not exceed one twelfth (1/12<sup>th</sup>) of Fiscal Year (FY) 2014-15 contract amount. The Total Contract Amount (TCA) to cover the monthly extensions shall be \$84,000.
7. **Amendment No. 1 (MH220019) with Jackie Y. Clark, Correctional Healthcare Consultant** revises and incorporates additional and enhanced privacy and security requirements applicable to the Agreement, by the delegated authority to the Directors of all Health Insurance Portability and Accountability Act of 1996 (HIPAA)-covered Departments to make all necessary alterations and adjustments to Business Associate Agreement language. There is no change to the Maximum Contract Amount (MCA).
