SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 372 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 19 new Agreements processed in the month of September 2013 as follows:

1. **Agreement (MH9041) with D. Taylor Enterprises, LLC**, is being executed under the Medi-Cal Professional Services Agreement. The term of the Agreement is from September 10, 2013, through June 30, 2014.
2. **Amendment 13 (MH120954) with Penny Lane Centers** adds Title IV-Group Home Aftercare Services (GHAS) Medi-Cal/Healthy Families (HF) funds in the amount of \$151,200 and GHAS Non Medi-Cal/Non HF funds in the amount of \$8,400 for Fiscal Year (FY) 2013-14 only. The revised Maximum Contract Amount (MCA) is \$25,560,175.
