SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 74 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 235 new Agreements processed in the month of June 2012, as follows:

1. **Agreement (79-2012-TTACB) with California Mental Health Services Authority (CalMHSA)** is being executed under the Participation Agreement. The term of the Agreement will be from March 1, 2012, through June 30, 2014.
2. **Amendment No. 2 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** adds \$105,960 for the Consumer Satisfaction Survey Project, related to Addendum A, Subsection A2.4.
