SUBJECT: **MENTAL HEALTH-SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 28 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 12 new Agreements processed in the month of September 2012, as follows:

1. **Amendment No. 1 (MH050054) with The University of Washington** provides the Problem Solving Treatment (PST) component of the two day on-site skills training known as the Mental Health Integration Program (MHIP) to be a stand-alone training. There is no change to the Maximum Contract Amount (MCA).
2. **Amendment No. 1 (MH120891) with The Los Angeles Free Clinic dba The Saban Free Clinic** revises for Service Exhibit (SE) 1048, "1115 Waiver Demonstration Project Healthy Way L.A. (HWLA) Tier II Specialty Mental Health Services for Adults (19-64 years of age)," Section 6.1.1 (Care Manager), for Fiscal Years (FYs) 2012-13, 2013-14, and 2014-15. There is no change to the MCA.
3. **Amendment No. 2 (MH120926) with South Central Health and Rehabilitation Program (SHARP)** adds Post-Release Community Supervision (PRCS) - Community Reintegration Program Medi-Cal/Healthy Families (HF) in the amount of \$50,000 and Non Medi-Cal/Non HF funds in the amount of \$50,000, with a revised MCA of \$10,116,399.

There is no change to the MCA.
7. **Amendment No. 2 (MH120956) with SHIELDS For Families** increases California Work Opportunity and Responsibility To Kids (CalWORKs) program in the amount of \$12,000, with a revised MCA of \$12,964,588.
8. **Amendment No. 3 (MH120965) with Telecare Corporation** increases Medi-Cal/HF to PRCS and decreases PRCS – Community Reintegration Program Non Medi-Cal/Non HF in the amount of \$151,440 and increases PRCS to \$302,880, with a revised MCA of \$12,450,344.
9. **Amendment No. 2 (MH120966) with Eldorado Community Service Center** revises SE 1048, 1115 Waiver Demonstration Project HWLA Tier II Specialty Mental Health Services for Adults (19-64 years of age).
10. **Amendment No. 4 (MH190075) with California State University, Long Beach Research Foundation** changes the name from California State University, Long Beach Foundation to California State University Long Beach Research Foundation.
11. **Amendment No. 1 (MH210027) with AIDS Healthcare Foundation** adds MHSA and PEI One-Time Funding in the amount of \$18,092 and adds Provider Number (PN) to be determined (TBD) located at 1400 S. Grand Avenue, Suite 801, Los Angeles, CA 90015, with a revised MCA of \$72,092.
