SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 55 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs, and execution of 12 new Agreements processed in the month of July 2012, as follows:

1. **Agreement (MH9034) with JAHI Family Services, Inc.**, is being executed as a Medi-cal Professional Services Agreement.
2. **Agreement (MH010090) with Antioch University** is being executed as an Affiliation Agreement.
3. **Amendment (MH29440) with AJ Barnert** adds new provision to the Agreement pursuant to the new Ordinance No. 2009-0026 (Los Angeles County Code 2.203), Defaulted Property Tax Reduction Program.
4. **Amendment No. 2 (MH050043) with The Regents of the University of California on behalf of the San Francisco Campus** extends the Statement of Work (SOW) and Fee Schedule (FS) to allow Contractor to complete the Child-Parent Psychotherapy (CPP) training and consultation service to the Department of Mental Health (DMH) and contracted agency clinicians.
5. **Amendment No. 2 (MH050049) with Los Angeles County Alliance for the Mentally Ill aka Los Angeles County Coordinating Council (LACCC)** corrects the contractor's name, revises Exhibit A of the SOW and Exhibit B of the FS, and decreases the Total Contract Amount (TCA) in the amount of \$73,000 for Fiscal Year (FY) 2012-13. The revised TCA is \$483,856.

6. **Amendment No. 11 (MH120736) with Children's Institute, Inc.**, supersedes the previous Amendment No. 11 to correct the Project ABC Family Wellness Network grant funds for FY 2011-12 with no change to the Maximum Contract Amount (MCA).
7. **Amendment No. 12 (MH120736) with Children's Institute, Inc.**, switches funding from Field Capable Clinical Services (FCCS) Child Early Periodic Screening, Diagnosis, and Treatment (EPSDT) Medi-Cal to Full Service Partnership (FSP) Child EPSDT Medi-Cal and FSP Child Wraparound EPSDT Medi-Cal for FY 2011-12. There is no change to the TCA.
8. **Amendment No. 18 (MH120742) with Didi Hirsch Psychiatric Service** decreases FSP Non Medi-cal/Non Healthy Families funds in the amount of \$220,000 and increases FSP Medi-Cal/Healthy Families funds in the amount of \$220,000. The amendment also decreases FCCS Medi-Cal/Healthy Families funds by \$185,760 and increases FCCS Non Medi-Cal/Non Healthy Families funds in the amount \$29,000 for FY 2011-12.
9. **Amendment No. 5 (MH120777) with Los Angeles Unified School District** allows for a technical correction to the FS of the agreement to identify the correct amounts for Prevention and Early Intervention (PEI) training, technical assistance, and Tier II One-Time Expenditure for FY 2011-12. There is no change to the MCA.
10. **Amendment No. 16 (MH120796) with San Fernando Valley Community Mental Health Center, Inc.**, allows for a technical correction to rescind the deletion of Medication Support, Mode 15, Service Function Code 62 for service delivery site located at 14550 Sherman Way, Van Nuys, CA 91405.
11. **Amendment No. 5A (MH120808) with The Children's Center of the Antelope Valley** replaces the current FS Subprogram Schedule - 4A (Attachment IV) with a revised FS Subprogram Schedule - 5A (Attachment IV) for FY 2011-12.

15. **Amendment No. 3 (MH120876) with Pacific Clinics** adds PEI Training funds in the amount of \$249,200 for FY 2012-13.
16. **Amendment No. 1 (MH120928) with Tessie Cleveland Community Services Corporation** adds PEI Transition Age Youth (TAY) Technical Assistance funds in the amount of \$200,000 for FY 2012-13.
