SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 27 amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and the execution of four new Agreements processed in the month of November 2011, as follows:

1. **Agreement (MH29427) with Cathleen Carlson** is being renewed as an Individual Provider for Medi-Cal professional services.
2. **Amendment No. 1 (MH29427) with Cathleen Carlson** anticipates implementing the transition of the State of California Department of Mental Health claiming system to comply with the Health Insurance Portability and Accountability Act (HIPAA) of 1996 in Los Angeles County. Implementation may impact Contractor's ability to submit claims to the County for a period of two to four months. The County and Contractor wish to mitigate any potential impact of said interruption on Contractor's business operations, and therefore, County has determined that it will provide an interim payment method.
3. **Amendment No. 1 (MH050049) with The Los Angeles County Alliance for the Mentally Ill aka Los Angeles County Coordinating Council (LACCC)** adds In Our Own Voice (IOOV) training and presentation program and the amount of \$46,560 to cover the cost of the program. The Revised Total Contract Amount (TCA) is \$556,856 for Fiscal Year (FY) 2011-12 only.
4. **Agreement (MH100203) with Pacific Clinics** is being executed under the Technological Needs Project for FYs 2011-12 through 2016-17.
5. **Amendment No. 1 (MH120697) with California Hispanic Commission, Inc.,** relocates service delivery site 3125 N. Broadway, Los Angeles, CA 90031 to 2309 Daly Street, Los Angeles, CA 90031. Shift Mental Health Services Act

"To Enrich Lives Through Effective And Caring Service"

(MHSA) – Full Service Partnerships (FSP) Non Medi-Cal/Non Healthy Families funds in the amount of \$26,000 to MHSA Field Capable Clinical Services (FCCS) Non Medi-Cal/Non Healthy Families funds in the amount of \$20,000 and to MHSA Wellness Centers Non Medi-Cal/Non Healthy Families funds in the amount of \$6,000. The revised MHSA FCCS (Medi-Cal/Healthy Families) Match Funds are \$69,986; there is no change to the Maximum Contract Amounts (MCAs) for FYs 2011-12, 2012-13, and 2013-14.

6. **Amendment No. 1 (MH120712) with St. Joseph Center** adds Homeless Services Funded Program Non Medi-Cal/Indigent funds in the amount of \$103,854 and Homeless Service Funded Program Medi-Cal funds in the amount of \$44,510. It also adds Mode 15, Service Function Codes (SFCs) 70-79 (Crisis Intervention) to provider No. 7720 at a provisional rate of \$3.88. The revised MCA for FY 2011-12 will be \$890,185. There is no change to the MCA for FYs 2012-13 and 2013-14.
7. **Amendment No. 1 (MH120727) with Braswell Rehabilitation Institute for Development of Growth and Educational Services, Inc. (BRIDGES)** shifts Department of Mental Health (DMH) Non Medi-Cal/Non Healthy Families funds in the amount of \$311,350 to DMH Medi-Cal/Healthy Families funds. It decreases MHSA Wellness Centers Non Medi-Cal/Healthy Families funds in the amount of \$74,000 and MHSA Wellness Center Medi-Cal/Healthy Families funds in the amount of \$20,000. The Amendment increases the MHSA Institution for Mental Disease (IMD) Step-Down Medi-Cal/Healthy Families funds in the amount of \$168,000. The new MCA will be \$2,470,517.
8. **Amendment No. 6 (MH120742) with Didi Hirsch Psychiatric Service** relocates Provider number 7209 from 111 N. La Brea Avenue, Suite 500 and Suite 700, Inglewood, CA 90301 to 323 N. Prairie Avenue, Inglewood, CA 90301.
9. **Amendment No. 2 (MH120756) with Foothill Family Service** increases MHSA Prevention and Early Intervention (PEI) Early and Periodic Screening Diagnosis and Treatment (EPSDT) Medi-Cal/Healthy Families Program funds in the amount of \$85,000 and increase PEI match funds in the amount of \$5,789 for FY 2011-12. The revised MCA is \$12,408,853.
10. **Amendment No. 1 (MH120763) with Helpline Youth Counseling, Inc.,** deletes Mode 15 (Outpatient Services), SFC 62 (Medication Support) from Provider No. 7574.

11. **Amendment No. 3 (MH120766) with Hillview Mental Health Center, Inc.,** adds MHSAs PEI funds in the amount of \$80,000 and One-Time PEI Program funds in the amount of \$20,000. The revised MCA amounts for FY 2011-12 and FY 2012-13 are \$9,267,800 and \$9,181,029, respectively.
12. **Amendment No. 2 (MH120780) with Mental Health America of Los Angeles** decreases MHSAs FSP Non Medi-Cal/Healthy Families Program Funds in the amount of \$325,633 and increases MHSAs FSP Medi-Cal/Healthy Families Program Funds in the amount of \$724,690 for FY 2011-12 only. The revised MCA is \$15,270,305.
13. **Agreement (MH120781) with Multiservice Family Center, Inc.,** is being superseded such that the Contractor will provide basic services to clients referred by DMH under the Organizational Agreement.
14. **Amendment No. 3 (MH120801) with South Central Health and Rehabilitation Program (SCHARP)** is a technical correction to Amendment No. 2, it adds Service Exhibit 13 to Provider Nos. 7409, 7549, and 7555. There is no change to the MCA.
15. **Amendment No. 1 (MH160178) with Braswell Rehabilitation Institute for Development of Growth and Educational Services, Inc. (BRIDGES)** deletes service delivery satellite sites located at B.R.I.D.G.E.S. Inc. dba Casitas Pacificas, 11925½ A-B Elliot Street, El Monte, CA 91732, 11931 A-B Elliot Street, El Monte, CA 91732, B.R.I.D.G.E.S. Inc. dba Glorieta Ardiente, 2603 West Avenue K-6, Lancaster, CA 93534, and B.R.I.D.G.E.S. Inc. dba Terreno Nuevo, 13192 Herrick Avenue, Sylmar, CA 91342.
16. **Agreement (MH200354) with Village Health Foundation, Inc.,** is being executed under the MHSAs Master Agreement for FYs 2011-16.

The following 5 amendments to Pharmaceutical agreements (17 to 21) revise Section 3 or 4 (Payments) to comply with Auditor-Controller's recommendations regarding pharmacy operations and revise Section 11 or 12 (Indemnification and Insurance), Paragraph B (General Provision for all Insurance Coverage), Subparagraph 3 (Cancellation of or Changes in Insurance) and Subparagraph 4 (Failure to Maintain Insurance):

29. **Amendment No. 4 (MH120792) with PROTOTYPES, Centers for Innovation in Health, Mental Health, and Social Services** adds funds in the total amount of \$381,857, with a revised MCA of \$6,533,978.
