SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 47 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 25 new Agreements processed in the month of October 2011, as follows:

- 1. Agreement (77676) with Netsmart Technologies, Inc.**, is being executed under the Integrated Behavioral Health Information System (IBHIS). The terms of the Agreement will be from October 18, 2011, through October 17, 2022.
