SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 58 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of nine (9) new Agreements processed in the month of December 2011, as follows:

- 1. Agreement (MH29428) with Individual Provider for Medi-Cal Professional Services** is being executed under Fee-For-Service (FFS) Individual for the provision of Medi-Cal specialty mental health services. The term of this Agreement is from December 8, 2011, through June 30, 2014.
- 2. Amendment No. 1 (MH29428) with Individual Provider for Medi-Cal Professional Services** adds new provision to the Agreement pursuant to the new Ordinance No. 2009-0026 (Los Angeles County Code 2.203), Defaulted Property Tax Reduction Program.
- 3. Amendment No. 2 (MH120573) with JWCH Institute, Inc.**, makes technical correction to revert \$25,247 to Family Focused Wellness Maximum Program Amount to reimburse Contractor for services provided under the Family Focused Wellness Plan prior to Amendment No. 1. Reduces Mental Health Services Act (MHSA) Institution for Mental Disease (IMD) Step Down Non-Medi-Cal Indigent funds in the amount of \$25,247 and increases MHSA Wellness/Client Run Centers Medi-Cal/Healthy Families (HF) funds in the amount of \$25,247. The Maximum Contract Amount (MCA) for Fiscal Year (FY) 2010-11 will remain the same at \$266,710.

4. **Amendment No. 6 (MH120709) with SHIELDS for Families** adds Department of Justice (DOJ) Second Chance Act Adult and Juvenile Offender Reentry Demonstration Projects Grant funds in the amount of \$135,000 for the provision of mental health services for incarcerated youth and their families. The revised MCA for FY 2011-12 will be \$10,138,635.
5. **Amendment No. 7 (MH120709) with SHIELDS for Families** increases MHSA Prevention and Early Intervention (PEI) Non Medi-Cal/HF in the amount of \$180,000 for the provision of Functional Family Therapy (FFT) mental health services to eligible youth and their families participating in the Los Angeles County Gang Violence Reduction Initiative, and in the amount of \$20,000 for Contractor staff to attend trainings toward their FFT credential/certification. The revised MCA for FY 2011-12 will be \$10,338,635.
6. **Amendment No. 3 (MH120715) with Tarzana Treatment Center, Inc.,** increases the MHSA PEI Non Medi-Cal/Non HF in the amount of \$52,500 for the provision of Tier II services to eligible Healthy Way LA (HWLA) enrollees. The revised MCAs for FYs 2011-12, 2012-13, and 2013-14 will be \$4,077,249, \$3,730,596, and \$3,730,596, respectively.
7. **Amendment No. 3 (MH120716) with Telecare Corporation** adds \$659,020 for the purchase of 25 additional beds for Telecare IMD Step Down Program at Provider Site 7647. The revised MCA amount for FY 2011-12 will be \$10,271,198, and for FYs 2012-13 and 2013-14 will remain the same.
8. **Amendment No. 3 (MH120735) with Childrens Hospital Los Angeles** increases the Child Mental Health Initiative-Project ABC Funded Program funded by Substance Abuse and Mental Health Services Administration (SAMHSA) Grant in the amount of \$94,223 to provide comprehensive, family-centered, culturally-competent mental health services to young children ages birth to five years and their families. The revised MCA will be \$12,206,832.
9. **Amendment No. 1 (MH120782) with Ocean Park Community Center** decreases Homeless Services Funded Program Non Medi-Cal/Indigent funds in the amount of \$84,900 and adds Homeless Services Funded Program Medi-Cal funds in the amount of \$169,800. It also adds the following mental health services to a new service delivery site located at 503 Olympic Boulevard, Santa Monica, CA 90401, Provider No. TBD: Mode 15, Services Function Codes (SFCs) 01-09 (Targeted Case Management), Mode 15, SFCs 10-19/30-59 (Mental Health Services), Mode 15, SFCs 70-79 (Crisis Intervention), Mode 45,

SFCs 20-29 (Community Client Services), and Mode 60, SFCs 64 and 70-79 (Client Supportive Services). The revised MCA will be \$509,504.

10. **Amendment No. 6 (MH120785) with Pacific Clinics** adds MHSA PEI Medi-Cal/HF to the Latina Youth Program in the amount of \$717,017. The revised MCA will be \$76,951,640.
11. **Amendment No. 5A (MH120792) with PROTOTYPES, Centers for Innovation in Health, Mental Health and Social Services** intends to shift and/or adjust funds at the subprogram level by modifying the current Financial Summary Subprogram (Schedule Attachment IV). There is no change to the MCA.
12. **Amendment No. 2 (MH120793) with Providence Community Services, LLC** adds funds to the MCA in the amount of \$36,000 to the Specialized Foster Care (SFC) – Department of Children and Family Services (DCFS) Multi-disciplinary Assessment Team (MAT) (Non Medical/Non HF) and \$144,000 to the SFC – Child Welfare Services (Medi-Cal/HF), for a combined total increase of \$180,000 for FY 2011-12. For FY 2012-13, it adds funds in the amount of \$72,000 to the SFC – DCFS MAT (Non Medi-Cal/Non HF), and \$288,000 in funds to the SFC – Child Welfare Services (Medi-Cal/HF) for a combined total increase of \$360,000. The new MCA for FYs 2011-12 and 2012-13 will be \$6,343,817 and \$6,516,252, respectively.
13. **Amendment No. 3 (MH120805) with Stirling Academy, Inc.**, increases California Work Opportunity and Responsibility to Kids (CalWORKs) funding by \$35,000. The revised MCA will be \$3,405,314.
14. **Agreement (MH040104) with LAMP, Inc.**, is being executed under the new Basic Living Support Services. The term of this Agreement is from November 29, 2011, through June 30, 2014.
15. **Agreement (MH150290) with Evergreen Pharmaceutical of California, Inc.**, is being executed under the Pharmacy Agreement. The term of this Agreement is from October 27, 2011, through June 30, 2015.
16. **Agreement (MH160210) with Villa Stanley East, Inc.**, is being superseded under Community Care Residential Facility Agreement for one (1) more fiscal year beginning July 1, 2011, through June 30, 2012.

17. **Amendment No. 3 (MH190076) with Mental Health Advocacy Services, Inc.**, extends the term of the Agreement for six months of FY 2011-12, beginning January 1, 2012, through June 30, 2012 to allow for the completion of the Request for Proposals (RFP) solicitation process. The Total Contract Amount (TCA) for the remaining six months of FY 2011-12 is \$202,450.
18. **Agreement (MH200355) with A Thousand Joys, Inc.**, is being executed under the MHSA Master Agreement. The term of this Agreement is from December 7, 2011, through June 30, 2016.
