SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 158 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 279 new Agreements processed in the month of June 2011, as follows:

1. **Agreement (MH010089) with The Regents of the University of California, Los Angeles, UCLA** is being executed under the Affiliation Agreement. The term of the Agreement will be from July 1, 2011 through June 30, 2014.
2. **Agreement (MH050050) with Multisystemic Therapy Services, Inc.**, is being executed under the Sole Source Consultant Services Agreement. The term of the Agreement will be from July 1, 2011 through June 30, 2016.
3. **Agreement (MH100779) with Counseling and Research Associates dba Masada Homes** is being executed under the Information Technology Services Agreement. The term of the Agreement will be from July 1, 2010 through June 30, 2016.
4. **Agreement (MH150213) with Hygeia Apothecary, Inc., dba Botica Del Sol** is being superseded for Fiscal Years (FYs) 2010-11, 2011-12, 2012-13, and 2013-14.
5. **Agreement (MH190090) with Venice Family Clinic** is being executed under the Unique Agreement. Under this subcontract Revenue Agreement, the maximum obligation of Contractor to Subcontractor may not exceed \$102,000 for FY 2011-12.

6. **Agreement (MH190091) with California Department of Mental Health – Metropolitan State Hospital** is being executed under the State Hospital Patient/Client Transportation Support Services Agreement. The term of the Agreement will be from July 1, 2011 through June 30, 2014.
7. **Agreement (MH200131) with The Regents of the University of California on behalf of the San Diego Campus** is being executed under the Mental Health Services Act (MHSA) Master Agreement. The term of the Agreement will be from July 1, 2011 through June 30, 2016.
8. **Agreement (MH29418) with Lisa Kantor, M.F.T.**, renews the agreements with individuals and group providers for the provision of Medi-Cal specialty Mental Health Services. The term of the Agreement will be from June 24, 2011 through June 30, 2014.
9. **Amendment No. 1 (MH010075) with University of Southern California Department of Contracts and Grants** creates a new permanent revenue source, administered by the State Department of Mental Health (SDMH), for the transformation and expanded delivery of mental health services provided by State and County agencies and requires the development of integrated plans for prevention, innovation, and system of care services.
10. **Amendment No. 1 (MH29418) with Lisa Kantor, M.F.T.**, anticipates implementing the transition of the SDMH claiming system to comply with the Health Insurance Portability and Accountability Act (HIPAA) of 1996 in Los Angeles County. Implementation may impact contractor's ability to submit claims to the County for a period of two to four months. The County and Contractor wish to mitigate any potential impact of said interruption on Contractor's business operations, and therefore County has determined that it will provide an interim payment method. Effective October 21, 2009, County and Contractor intend to amend Agreement to add a new provision to the Agreement pursuant to the new Ordinance No. 2009-0026 (Los Angeles County Code 2.203), Defaulted Property Tax Reduction Program.
11. **Amendment No. 2 (MH040096) with 1736 Family Crisis Center** adds a new temporary shelter site to the existing Basic Living Support Services Agreement to provide shelter services to Domestic Violence clients.
12. **Amendment No. 1 (MH050038) with California Mental Health Directors Association** add MHSA – Prevention and Early Intervention (PEI) funds in the amount of \$9,377 to the Total Compensation Amount (TCA). For FYs 2010-11,

2011-12, and 2012-13, the revised TCAs will be \$289,377, \$289,377, and \$289,377, respectively.

13. **Amendment No. 1 (MH050044) with PRACTICEWISE, LLC**, increases the MHSA-PEI funds in the amount of \$582,486 for FY 2010-11 through FY 2011-12, with a revised TCA of \$3,494,917.
