SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 45 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of ten (10) new Agreements processed in the month of August 2010, as follows:

- 1. Agreement (MH060038) with Catholic Healthcare West dba Northridge Hospital Medical Center – Roscoe Blvd. Campus** is being executed to renew under the Fee-For-Service Agreement and allow for uninterrupted, medically necessary acute psychiatric inpatient hospital services and administrative day services to severely mentally ill clients who reside throughout the County of Los Angeles.
- 2. Amendment No. 1 (MH060047) with HealthSmart Pacific Inc. dba Pacific Hospital of Long Beach** adds Psychiatric Mobile Response Team (PMRT) Psychiatric Outreach Diversion Program (PDP) services from July 1, 2010 to June 30, 2011.
- 3. Amendment No. 2 (MH120570) with Hamburger Home dba Aviva Family and Children's Services dba Aviva Center** changes the service delivery site for Aviva Center Valley Wraparound Program under existing Provider Number (PN) 7626 from 6400 Laurel Blvd., Suite 230, North Hollywood, CA 91606 to 5200 Lankershim Blvd., North Hollywood, CA 91601. There is no change to the Maximum Contract Amount (MCA).
- 4. Amendment No. 3 (MH120579) with Pacific Asian Counseling Services** increases MHSA Adult Field Capable Clinical Services (FCCS) Medi-Cal/Healthy Families (HF) in the amount of \$219,995, with a revised MCA of \$2,289,352.

There is no change to the MCA.
8. **Amendment No. 2 (MH120638) with Hillside**s makes a technical adjustment to fix an error which resulted in a misallocation on the Financial Summary. Shifts \$1,931,166 from MHSA Full Service Partnership (FSP) Child Medi-Cal/HF to MHSA FCCS Child Medi-Cal/HF. There is no change to the MCA.
