SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 21 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of six (6) new Agreements processed in the month of January 2011, as follows:

1. **Agreement (MH010083) with Loyola Marymount University** is being executed under Affiliation Agreement For Student Professional Development Programs. The term of the Agreement will be from January 10, 2011 through June 30, 2015.
2. **Amendment No. 2 (MH020021) with Bowers Companies, Inc., dba Bowers Ambulance Services** correctly states the name of the contractor from Bowers Ambulance Service to Bowers Companies, Inc., dba Bowers Ambulance Services to be in agreement with the Articles of Incorporation.
3. **Agreement (MH030180) with MHP Consulting Groups, Inc.,** is being executed under Services Agreement For Clinical Assessment Programs. The term of the Agreement will be from February 1, 2011 through June 30, 2012.
4. **Amendment No. 1 (MH030180) with MHP Consulting Group, Inc.,** adds new Ordinance No. 2009-0026 (Los Angeles County Code 2.206), Defaulted Property Tax Reduction Program, and revises the Health Insurance Portability and Accountability Act (HIPAA) to add the Health Information Technology For Economic and Clinical Health Act (HITECH) language.
5. **Amendment No. 7 (MH050019) with Mental Health America of Los Angeles** adds MHSA Community Services and Support (CSS) funding for the implementation of the Workforce Education and Training Programs (WET); also

extends the Agreement for an additional 12 months from July 1, 2011 through June 30, 2012 with a Total Contract Amount (TCA) of \$781,100.

6. **Amendment No. 2 (MH050025) with Multisystemic Therapy Services, Inc.**, increases funds for training and consultation fees in the amount of \$18,700 and licensure fees in the amount of \$2,500, with a revised Maximum Contract Amount (MCA) of \$127,200.
7. **Agreement (MH050045) with Pacific Clinics** is being executed under Consultant Services Agreement. The term of this Agreement will be from January 4, 2011 through June 30, 2012.
8. **Amendment No. 2 (MH120575) with Los Angeles Unified School District** decreases Specialized Foster Care – Child Welfare Services Funded Programs in the amount of \$6,800, with a revised MCA of \$3,660,388.
9. **Amendment No. 6 (MH120582) with Prototypes, Centers for Innovation in Health, Mental Health and Social Services** shifts MHSA Full Service – Adult Non-Medi-Cal/Indigent in the amount of \$100,000 to MHSA Field Capable Clinical Services (FCCS) Non-Medi-Cal/Indigent funded program. There is no change to the MCA.
10. **Amendment No. 2 (MH120649) with New Horizons Family Center, Inc.**, moves its Outpatient Program of current service delivery site Provider Number (PN) 7529 from 1251 S. Glendale Avenue, Glendale, CA 91205 to 744 S. Glendale Avenue, Glendale, CA 91205. There is no change to the MCA.
11. **Amendment No. 4 (MH120653) with Optimist Boys' Home and Ranch, Inc.**, increases MCA to restore a portion of previously curtailed funds, and increases Other Mental Health Services Medi-Cal/Healthy Families (HF) by \$256,940, with a revised MCA of \$5,712,269.
12. **Amendment No. 2 (MH120670) with St. John's Hospital and Health Center** reduces MHSA FCCS Non-Medi-Cal/Indigent Funded Program in the amount of \$7,500 and adds MHSA FCCS Medi-Cal/HF Funded Program in the amount of \$134,288; reduces MHSA FCCS Non-Medi-Cal/HF Funded Program in the amount of \$7,500 and adds MHSA FCCS Medi-Cal/HF Funded Program in the amount of \$110,132 for Fiscal Year (FY) 2011-12, for the provision of providing additional Medi-Cal/HF–MHSA FCCS. For FYs 2010-11 and 2011-12 the total MCAs will increase by \$126,788 and \$102,632, with a revised MCA of \$2,873,821 and \$2,849,665, respectively.

13. **Amendment No. 2 (MH150264) with Pai and Chan Pharmacy Corporation dba Medical Center Pharmacy** changes name from Miyade Medical Center Pharmacy, Inc., dba Medical Center Pharmacy to Pai and Chan Pharmacy Corporation dba Medical Center Pharmacy.

The following two (2) Amendments to LE Agreements (14 and 15) add a new Funded Program – Homeless Services to expand residential mental supportive services, chronically homeless adults:

14. **Amendment No. 1 (MH120650) with Ocean Park Community Center** adds Mode 15, Service Function Codes (SFCs) 70-79 (Crisis Intervention); Mode 45, SFCs 20-29 (Community Client Services); and Mode 60, SFCs 64/70-79 (Client Supportive Services) and adds Homeless Services Funded Program Non-Medi-Cal/Indigent in the amount of \$111,740 for FY 2010-11 and \$223,480 for FY 2011-12.
15. **Amendment No. 1 (MH120673) with Step Up on Second Street, Inc.**, adds the following services to delivery site location 6362 Hollywood Boulevard, Suite 214 Hollywood, CA 90028, PN TBD; Mode 15, SFCs 01-09 (Targeted Case Management) at a provisional rate of \$1.75; Mode 15, SFCs 10-19/30-59 (Mental Health Services without Psychological Testing) at a provisional rate of \$2.28; Mode 15, SFCs 60-69 (Medication Support) at a provisional rate of \$3.37; Mode 15, SFCs 70-79 (Crisis Intervention) at a provisional rate of \$3.06; Mode 45, SFCs 20-29 (Community Client Services) at a provisional rate of \$34.08; and Mode 60, SFCs 60-72/70-79 (Client Supportive Services); adds Homeless Services Funded Program Non-Medi-Cal/Indigent in the amount of \$154,376 and Homeless Services Funded Program Medi-Cal/HF in the amount of \$96,362, with a revised MCA of \$2,934,047.

The following three (3) Amendments (16 - 18) to LE Agreements modify the Financial Summary, Attachment III, to further facilitate the Federal Certified Public Expenditure (CPE) rules and allow for maximum flexibility for payments of Medi-Cal and HF Services by combining the “Other Mental Health Services for Clients Under the Age of 21 Years” and “Other Mental Health Services for Clients 21 Years of Age or Older” Funded Programs into a Funded Program titled “Other Mental Health Services (CPE Funded Programs)”:

16. **Amendment No. 2 (MH120566) with El Centro del Pueblo, Inc.**
17. **Amendment No. 2 (MH120607) with Braswell Rehabilitation Institute for Development of Growth and Educational Services, Inc. (BRIDGES)**

18. Amendment No. 3 (MH120653) with Optimist Boys' Home and Ranch, Inc.

The following three (3) Amendments to Specialized Agreements (19 - 21) revise language pertaining to "Contractor's Obligations as a Business Associate Under the HIPAA of 1996 and the HITECH (Business Associate Agreement)" to bring the Agreement into compliance with changes in HIPAA laws and regulations:
