SUBJECT: MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 24 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of nine (9) new Agreements processed in the month of November 2010, as follows:

1. **Agreement (MH9026) with Mary Odom** is a new agreement with Medi-Cal Professional Services, Fee-For-Service (FFS) Group.
2. **Agreement (MH29399) with Jeffrey Cutler, Ph.D.**, is a new agreement with Individual Provider for Medi-Cal Professional Services, FFS Individual.
3. **Agreement (MH050044) with Practice Wise, LLC**, is a new agreement under Consultant Services.
4. **Agreement (MH060063) with Alta Hollywood Hospital, Inc., dba Hollywood Community Hospital of Van Nuys** is a new agreement with FFS Medi-Cal Acute Psychiatric Inpatient Hospital Services.
5. **Agreement (MH100171) with The Institute for the Redesign of Learning dba Almansor Center**, is a new agreement under Technological Needs Project.
6. **Agreement (MH120692) with Southern California Alcohol and Drug Programs, Inc.**, is a new agreement under LE.
7. **Amendment No. 3 (MH150229) with Thu Pharmacy** changes the address of Thu Pharmacy's service site from 15418 Crenshaw Boulevard, Gardena, CA 90249 to 15735 Hawthorne Boulevard, Suite 110, Lawndale, CA 90260.

8. **Amendment No. 3 (MH120584) with San Fernando Valley Community Mental Health Center, Inc.,** decreases Homeless Services Non-Medi-Cal/Indigent Funded Program in the amount of \$137,861, with a revised Maximum Contract Amount (MCA) of \$28,818,840.
9. **Amendment No. 3 (MH120627) with Exodus Recovery, Inc.,** adds Specialized Foster Care Funded Program Medi-Cal/Healthy Families in the amount of \$678,836, and increases MHSA Urgent Care Centers/Crisis Resolution Services Non-Medi-Cal/Indigent Funded Program in the amount of \$928,836, which includes a one-time cost of \$250,000 for build out costs for Exodus Recovery Urgent Care Center to serve adolescents at: 1920 Marengo Street, 1st Floor, Los Angeles, CA 90033, with a revised MCA for Fiscal Year (FY) 2010-11 of \$13,926,214 and for FY 2011-12 of \$13,676,214.
10. **Amendment No. 1 (MH120645) with LAMP, Inc.,** increases Mental Health Services Act (MHSA) Wellness/Client - Run Centers in the amount of \$336,000 for FY 2010-11, with a revised MCA of \$2,344,545.
11. **Amendment No. 3 (MH120658) with Penny Lane Centers** increases the Specialized Foster Care Funded Program Medi-Cal/Healthy Families in the amount of \$1,212,840 for the purpose of providing Wraparound services under the Katie A. Strategic Plan, with a revised MCA of \$19,779,799.
12. **Amendment No. 3 (MH120659) with Personal Involvement Center, Inc.,** increases the Specialized Foster Care Funded Program Medi-Cal/Healthy Families in the amount of \$808,560 for the purpose of providing Wraparound services under the Katie A. Strategic Plan, with a revised MCA of \$2,933,636 and \$2,933,636.
13. **Amendment No. 2 (MH120660) with Phoenix Houses of Los Angeles, Inc.,** adds Mode 15, Service Function Code 58 (Therapeutic Behavioral Services) at a provisional rate of \$2.25 to Provider Number (PN) 7356. There is no change to the MCA.
14. **Amendment No. 4 (MH120664) with SHIELDS For Families** modifies the current address located at 12021 South Wilmington Avenue, Los Angeles, CA 90059, PN 7573, to specifically identify the address as located at 12021 South Wilmington Avenue, Lot C, Los Angeles, CA 90059. No change to the MCA.

15. **Amendment No. 4 (MH120672) with Star View Counseling Centers, Inc.,** adds Juvenile Justice Program Title IV-E Multi-Systemic Therapy (MST) Medi-Cal/Healthy Families in the amount of \$400,000 to continue to provide MST services to Probation youth, with a revised MCA of \$29,413,191.

The following three (3) Amendments to Specialized Agreements (16 to 18) revise language pertaining to "Contractor's Obligations as a Business Associate Under the Health Insurance Portability and Accountability Act (HIPAA) of 1996 and the Health Information Technology for Economic and Clinical Health Act (Business Associate Agreement)" to bring the Agreement into compliance with changes in HIPAA laws and regulations:

The following three (3) Amendments to Legal Entity Agreements (22 to 24) increase Specialized Foster Care Funded program Non Medi-Cal/Indigent Maximum Program to provide Multidisciplinary Assessment Treatment (MAT) under Katie A. Strategic Plan:

22. **Amendment No. 3 (MH120643) with Kedren Community Health Center, Inc.,** increases Specialized Foster Care Funded Program Non-Medi-Cal/Indigent Maximum Program Amount in the amount of \$11,400, to provide Multidisciplinary Assessment Treatment (MAT) under Katie A. Strategic Plan. The new MCA will be \$27,426,642 and \$27,276,642.

23. **Amendment No. 7 (MH120654) with Pacific Clinics** increases Specialized Foster Care Funded Program Non-Medi-Cal/Indigent Maximum Program Amount in the amount of \$6,500, to provide MAT under Katie A. Strategic Plan. The new MCA will be \$75,452,879 and \$73,551,162.
24. **Amendment No. 2 (MH120659) with Personal Involvement Center, Inc.,** increases Specialized Foster Care Funded Program Non-Medi-Cal/Indigent Maximum Program Amount in the amount of \$3,300, to provide MAT under Katie A. Strategic Plan. The new MCA will be \$2,125,076.
