MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 439 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers). Clinical Assessment programs and execution of one (1) new Agreement processed in the month of January 2010, as follows:

- 1. Amendment No. 3 (DMH-02425) with City of Long Beach supersedes Amendment #1. Ms. Corinne Schneider, Manager of Human Social Services, was not authorized to sign. Mr. Patrick West is the authorized signer.
- Agreement (MH020031) with Ambuserve, Inc., is a new Patient Transportation 2. Service Agreement. The term of this agreement shall commence on January 11. 2010, and shall continue through June 30, 2012. There is no Maximum Contract Amount (MCA) for this agreement.
- Amendment No. 4 (MH050020) with Karen Bollow provides revised language 3. pertaining to "Contractor's Obligation as a Business Associate Under the Health Insurance Portability and Accountability Act (HIPAA) of 1996 and the Health Information Technology for Economic and Clinical Health Act (Business Associate Agreement)" to bring the Agreement into compliance with changes in HIPAA laws and regulations.
- 4. Amendment No. 2 (MH050026) with Inez K. Mann dba Mann and Associates decreases County General Funds (CGF) in the amount of \$75,000 and adds \$105,000, one time only, MHSA Community Services and Supports (CSS) funds. The revised MCA will be \$180,000.

- 5. Amendment No. 4 (MH060007) with Brotman Medical Center, Inc., extends the term of the Psychiatric Mobile Response Team (PMRT) Psychiatric Outreach Diversion Program (PDP) to enable Brotman Medical Center, Inc., to provide services to clients who are uninsured.
