SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 108 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of August 2008, as follows:

- 1. Amendment No. 5 (MH120149) with Cedars-Sinai Medical Center** changes the service delivery site address from 8730 Alden Drive – Thaliens, Room W112, Los Angeles, CA 90048 to 8730 Gracie Allen Drive, Plaza Level West Wing, Los Angeles, CA 90048 under existing Provider Number (PN) 1980. There is no change to the Maximum Contract Amount (MCA).
- 2. Amendment No. 10 (MH120177) with South Central Health and Rehabilitation Program (SCHARP)** deletes Project for Assistance in Transition from Homelessness (PATH) Plan from existing PN 7409 located at 8836 South Vermont Avenue, Los Angeles, CA 90044, and adds PATH Plan to existing PN 7242 located at 5201 South Vermont Avenue, Los Angeles, CA 90037. There is no change to the MCA.

There is no change to the MCA.

106. **Amendment No. 7 (DMH-01817) with Para Los Ninos** increases FFP by \$88,869 and EPSDT-SGF by \$88,432 with a revised MCA of \$755,401.
107. **Amendment No. 6 (DMH-01828) with "Serenity": Infant Care Homes** increases FFP by \$570 and EPSDT-SGF by \$471 with a revised MCA of \$374,641.
108. **Amendment No. 6 (DMH-01836) with St. John's Hospital and Health Center** decreases DCFS AB 1733 by \$19,960, DCFS AB 2994 by \$19,959, and AB 3632 by \$85,463. It increases FFP by \$375,999 and EPSDT-SGF by \$219,765 with a revised MCA of \$3,089,851.
