SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 83 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of February, as follows:

- Amendment No. 2 (MH050011) with California Mental Health Directors Association (CMHDA)** implements a technical adjustment to correct Exhibit B-1 (Fee Schedule) to appropriately reflect the Board approved funding. There is no change to the Total Compensation Amount (TCA).
- Amendment No. 2 (MH050015) with National Mental Health Association of Greater Los Angeles** adds AB2034 funding in the amounts of \$80,000 for Immersion Training and \$68,000 for Data Collection/Analysis for a total increase of \$148,000. The revised TCA for Fiscal Year (FY) 2007-08 will be \$1,253,003.
- Amendment No. 4 (MH120162) with Hillview Mental Health Center, Inc.,** changes the method of reimbursement from Negotiated Rate to Cost Reimbursement for the following Short-Doyle/Medi-Cal (SD/MC) services: Residential Other (Mode 5, Service Function Codes (SFCs) 60-64) at a rate of \$222.10; Semi-Supervised Living (Mode 5, SFCs 80-84) at a rate of \$112.00; Targeted Case Management Services (TCMS) (Mode 15, SFCs 01-09) at a rate of \$1.85; Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59) at a rate of \$2.35; Medication Support (Mode 15, SFCs 60-69) at a rate of \$4.35; Crisis Intervention (Mode 15, SFCs 70-79) at a rate of \$3.51; Mental Health Promotion (Mode 45, SFCs 10-19) at a rate of \$78.00; and Community Client Services (Mode 45, SFCs 20-29) at a rate of \$78.00. There is no change to the Maximum Contract Amount (MCA).

4. **Amendment No. 4 (MH120168) with National Mental Health Association of Greater Los Angeles** increases Mental Health Services Act (MHSA) Adult Full Service Partnership (FSP) funds in the amount of \$22,600, increases MHSA Adult FSP Flex Funds in the amount \$14,097, and increases Federal Financial Participation (FFP) Medi-Cal revenue in the amount of \$11,300. The revised MCA will be \$15,525,697.
5. **Amendment No. 1 (MH120198) with California Hispanic Commission, Inc.,** adds a new MHSA Wellness/Client Run-Center service site identified as California Hispanic Commission A & D Abuse-OP, located at 10012 Norwalk Blvd., Santa Fe Springs, CA 90670. There is no change to the MCA.
6. **Amendment No. 1 (MH120227) with Health Research Association** changes delivery site. Contractor will relocate its Provider Number (PN) 6810 service delivery site from the site located at 530 South Catalina Street, Suite 202, Los Angeles, CA 90020, to a new site located at 600 St. Paul Avenue, Suite 100, Los Angeles, CA 90017. There is no change to the MCA.
7. **Amendment No. 1 (MH120237) with LAMP, Inc.,** deletes the following services; MHSA Wellness Centers – Non Client Run (Mode 15, SFCs 01-09, 10-19/30-59, and 60-69) from PN 7134. It also identifies the Contractor's service delivery sites: PN 7134 is located at 627 San Julian Street, Los Angeles, CA 90014, and PN 7202 is located at 527 South Crocker Street, Los Angeles, CA 90013. There is no change to the MCA.
