SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 34 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of February, as follows:

1. **Amendment No. 5 (DMH-01750) with ValueOptions, Inc.**, increases the benefit reimbursement rates for Speciality Mental Health Services provided by network preferred providers for Fiscal Year (FY) 2006-07. For FY 2006-07 the Maximum Contract Amount (MCA) shall remain at \$1,500,000.
2. **Amendment No. 1 (MH010015) with Mt. San Antonio College** amends the Agreement to include Mental Health Services Act (MHSA) language.
3. **Amendment No. 3 (MH120008) with California Institute of Health and Social Services, Inc., dba Alafia Mental Health Institute** adds a new service site located at 3701 Stocker Street, Room 310, Los Angeles, CA 90008. The MCA shall remain at \$1,434,000.
4. **Amendment No. 4 (MH120013) with Children's Institute, Inc.**, adds MHSA Children Full Service Partnership (FSP) funds for FY 2006-07 in the amount of \$276,296, which includes MHSA one-time costs in the amount of \$72,313, Client Supportive Services for \$23,496, Mental Health Services (MHS) for \$110,145, and MHSA Plan III for \$70,342, and adds Early and Periodic Screening, Diagnosis, and Treatment-Federal Financial Participation (EPSDT-FFP) in the amount of \$318,500 and EPSDT-State General Funds (SGF) in the amount of \$260,342, for a total increase of \$855,138. The revised MCA for FY 2006-07 will be \$9,844,824.

5. **Amendment No. 3 (MH120023) with Five Acres – The Boys' and Girls' Aid Society of Los Angeles County**, for FYs 2006-07, 2007-08, and 2008-09 intends to amend the following Provisional Rates under Cost Reimbursement: Mode 10, Service Function Codes (SFCs) 95-99 (Day Rehabilitative: Full Day) from \$123.18 to \$129.09; Mode 15, SFCs 10-19/30-59 MHS from \$2.04 to \$2.14; Mode 15, SFCs 60-69 (Medical Support Services) from \$2.38 to \$2.49; and Mode 15, SFCs 70-79 (Crisis Intervention) from \$2.73 to \$2.86. The MCA shall remain at \$9,710,651.
6. **Amendment No. 4 (MH120030) with Hathaway-Sycamores Child and Family Services** adds MHSA Plan I FSP in the amount of \$848,662, which includes \$442,312 for Child and \$406,350 for Transition Age Youth (TAY). It also adds a new satellite service delivery site to Provider No. (PN) 7599 and adds Mode/SFC to PNs 7278, 7599, and 7600. The revised MCA is \$24,889,376.
7. **Amendment No. 2 (MH120037) with Institute for Multicultural Counseling & Education Services, Inc., (IMCES)** deals with the Contractor's submission and acceptance for the delivery of FSP services as added to the Agreement's Service Exhibit listing. This action reflected the FY 2006-07, and the MCA will be increased by \$456,639 with a revised MCA of \$1,305,239. The MCA for FYs 2007-08 and 2008-09 will remain \$848,600.
8. **Amendment No. 4 (MH120044) with The Los Angeles Child Guidance Clinic** deals with the Contractor's submission and acceptance for the delivery of FSP services as added to the Agreement's Service Exhibit listing. This action reflected the FY 2006-07, and the MCA will be increased by \$442,313 with a revised MCA of \$12,124,289. The MCA for FYs 2007-08 and 2008-09 will remain \$11,681,976.
9. **Amendment No. 3 (MH120050) with Olive Crest Treatment Center, Inc.**, changes the provider site from 15545 Bellflower Boulevard, Suite A, Bellflower, CA 90706 to 17800 Woodruff Avenue, Bellflower, CA 90706. The MCA remains at \$1,025,121 for FYs 2006-07, 2007-08, and 2008-09.
10. **Amendment No. 5 (MH120051) with Pacific Clinics** adds \$1,611,984 for MHSA Children FSP funds, \$877,400 for MHSA TAY FSP funds, \$1,530,571 for MHSA Adult FSP funds, and \$437,500 for MHSA Older Adult FSP funds. The revised MCA is \$53,164,359.

11. **Amendment No. 5 (MH120056) with Portals House** adds Crisis Intervention (Mode 15, SFC 77) at a rate of \$3.74 under existing provider number 7512. The MCA remains \$11,618,177.
12. **Amendment No. 3 (MH120071) with Vista Del Mar Child and Family Services** adds a new service delivery satellite site located at 11222 S. La Cienega Boulevard, Suite 115, Los Angeles, CA 90304. Services to be provided at this site include Targeted Case Management Services, Mode 15, SFCs 01-09, and Mental Health Services, Mode 15, SFCs 10-19/30-59, under the existing PN 7196. MCA remains the same.
13. **Amendment No. 2 (MH120073) with Alcott Center for Mental Health Services** for FY 2006-07 adds MHSA Westside Urgent Community Services Program (WUCSP) funds in the amount of \$154,180, EPSDT-FFP in the amount of \$8,700, non EPSDT-FFP in the amount of \$51,500, and EPSDT-SGF in the amount of \$7,111, for a total increase of \$221,491. The revised MCA for FY 2006-07 is \$1,490,258. For FY 2007-08 this amendment also adds MHSA WUCSP funds in the amount of \$264,300, EPSDT-FFP in the amount of \$14,900, non EPSDT-FFP in the amount of \$88,300, and EPSDT-SGF in the amount of \$12,179, for a total increase of \$379,679. The revised MCA for FY 2007-08 will be \$1,648,446.
14. **Amendment No. 3 (MH120079) with California Hispanic Commission, Inc.,** adds \$466,638 in MHSA funds, which includes MHSA Adult FSP in the amount of \$361,171 and non EPSDT-FFP in the amount of \$105,467. The revised MCA is \$1,722,938.
15. **Amendment No. 5 (MH120103) with Hillview Mental Health Center, Inc.,** adds \$485,410 of MHSA funds to transform the mental health system by providing outreach, education, services and support to mentally ill clients residing in the County of Los Angeles. The revised MCA is \$8,400,319.
16. **Amendment No. 2 (MH120112) with New Directions, Inc.,** adds Substance Abuse and Mental Health Services Administration (SAMHSA) funds in the amount of \$54,495 for the provision of outreach, care coordination, case management and access to residential services for veterans served with a serious mental illness. The revised MCA is \$228,763.

17. **Amendment No. 2 (MH120114) with Optimist Boys' Home and Ranch, Inc.,** adds a new service delivery site located at 7003 N. Figueroa Street, Los Angeles, CA 90041 under the existing PN 7444.
18. **Amendment No. 2 (MH120115) with Pacific Asian Counseling Services** reallocates current ongoing California Work Opportunity and Responsibility to Kids (CalWORKs) Program funding to show a revised ongoing CalWORKs Program allocation breakdown: \$300,375 for Mental Health Services and \$33,375 for Community Outreach Services. The MCA remains at \$2,169,151.
19. **Amendment No. 6 (MH120127) with South Central Health and Rehabilitation Program (SCHARP)** changes the name from Wilshire Child Services dba FENTRY to SCHARP-Child Day Treatment. It also changes the address from 5022 S. Wilshire Blvd., Los Angeles, CA 90062 to 3320 W. Adams Boulevard, Educational Bldg., Los Angeles, CA 90018. The MCA remains at \$5,788,375.
20. **Amendment No. 7 (MH120127) with SCHARP** adds MHSA Adult FSP in the amount of \$159,179 and EPSDT-FFP in the amount of \$46,142, for a total increase of \$205,321. The revised MCA is \$5,985,104.
21. **Amendment No. 7 (MH120128) with Special Service for Groups** adds MHSA funds for Children, TAY, Adult, and Older Adult in the amount of \$3,083,104. In addition, it adds MHSA FSP services: Community Outreach Services to an existing service delivery site located at 520 South La Fayette Park Place, Los Angeles, CA 90057; Medication Support Services, Crisis Intervention Services and Community Outreach Services to a delivery site located at 19401 S. Vermont Avenue, Suite A-201, Torrance, CA 90502; Crisis Intervention Services, Community Outreach Services to service delivery site located at 5900 Sepulveda Boulevard., #425, Van Nuys, CA 91411; and Community Outreach Services to service delivery site located at 605 W. Olympic Boulevard., #780, Los Angeles, CA 90015. The revised MCA is \$20,397,865.
22. **Amendment No. 6 (MH120137) with Telecare Corporation** increases Provisional Cost Reimbursement Rates for the following Short-Doyle/Medi-Cal services: Targeted Case Management Services, Mode 15, SFCs 01-09, from \$1.44 to \$1.79; Mental Health Services, Mode 15, SFCs 10-19/30-59 from \$1.96 to \$2.26; Medication Support, Mode 15, SFCs 60-69 from \$3.75 to \$4.39; and Crisis Intervention, Mode 15, SFCs 70-79 from \$3.36 to \$3.79. The MCA shall remain the same.

23. **Amendment No. 2 (MH120140) with VIP Community Mental Health Center, Inc. – VIP CMHC** changes address for PN 7480 from 1721 Griffin Avenue, Los Angeles, CA 90031 to 1721 and 1733 Griffin Avenue, Los Angeles, CA 90031. The MCA remains at \$5,858,822.

The following nine (9) amendments to Legal Entity Agreements (24 to 32) increase the Psychiatric Diversion Program (PDP) rate from \$2,500 to \$3,300 per eligible admission and add a specific new Service Exhibit B (Psychiatric Inpatient Hospital Services PMRT Diversion Program) effective January 9, 2007:
