SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 54 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of May, as follows:

1. **Amendment No. 9 (DMH-01934) with California Institute for Mental Health (CIMH)**, adds California Work Opportunities and Responsibilities to Kids Act (CalWORKs) funds in the amount of \$35,000 from the Total Compensation Amount (TCA) for additional consultation services and technical assistance in the development and implementation of an outcome measurement system for the CalWORKs program.
2. **Amendment No. 5 (DMH-02066) with National Mental Health Association of Greater Los Angeles**, adds \$100,000 in one-time only Substance Abuse and Mental Health Services Administration (SAMHSA) Federal Block Grant funds for the transition of the AB 2034 data collection and evaluation activities to the Mental Health Services Act (MHSA) data collection systems.
3. **Amendment No. 3 (DMH-02096) with Asian American Drug Abuse Program, Inc.**, adds SAMHSA grant funds to the Maximum Contract Amount (MCA) for the Targeted Capacity Expansion (TCE) program in the pro-rated amount of \$326,250 for Fiscal Year (FY) 2005-06, and annualized amounts of \$472,500 for FY 2006-07 and \$496,250 for FY 2007-08.
4. **Amendment No. 4 (DMH-02104) with Counseling and Research Associates, Inc. dba Masada Homes**, adds Early and Periodic Screening, Diagnosis, and Treatment (EPSDT)-County General Funds (CGF) in the amount of \$7,761, EPSDT-Federal Financial Participation (FFP) in the amount of \$42,500, and EPSDT-State General Funds (SGF) funds in the amount of \$34,739 for a

combined total of \$85,000, to the MCA for funding additional school-based services in Hawaiian Gardens for FY 2005-06. For FYs 2006-07 and 2007-08 adds EPSDT-CGF funds in the amount of \$45,650 EPSDT-FFP Medi-Cal funds in the amount of \$250,000, and EPSDT-SGF funds in the amount of \$204,350, for a combined total for each fiscal year of \$500,000 to the MCA.

5. **Amendment No. 4 (DMH-02106) with Harbor View Rehabilitation Center, Inc. dba Harbor View Adolescent Center**, amends Agreement by reducing \$9,965 of \$54,572 originally allocated in CGF local match from the Non-EPSDT Medi-Cal Program, and adding \$9,965 in CGF to the EPSDT Medi-Cal Program for the CGF local match for FYs 2005-06, 2006-07, and 2007-08.
6. **Amendment No. 6 (DMH-02114) with Penny Lane Centers**, increases ongoing CalWORKs funds to MCA in the amount of \$70,000 for FYs 2005-06, 2006-07, and 2007-08.
7. **Amendment No. 8 (DMH-02120) with SHIELDS For Families**, adds CGF in the amount of \$150,000 for Functional Family Therapy (FFT) services to indigent probation and youth under Provider Number 7465 for FYs 2005-06, 2006-07, and 2007-08.
8. **Amendment No. 5 (DMH-02272) with Apsen Community Services**, amends Agreement to reflect the name change of the Contractor specified in the Legal Entity Agreement from Aspen Community Services to Providence Community Services, LLC.
9. **Amendment No. 6 (DMH-02273) with Associated League of Mexican-Americans, Inc.**, shifts funds in the amount of \$100,000 from CalWORKs-Community Outreach Services (COS), to CalWORKs-Mental Health Services (MHS) for FY 2005-06 only.
10. **Amendment No. 6 (DMH-02288) with Community Counseling Services of Los Angeles, Inc.**, changes the method of reimbursement from Negotiated Rate to Cost Reimbursement. Amends the Provisional Rate for Adult Crisis Residential, Mode 05, Service Function Codes (SFCs) 40-49 from \$135.73 to \$223.85; Targeted Case Management Services, Mode 15, SFCs 01-09 from \$1.29 to \$1.47; Provisional Rate for MHS, Mode 15, SFCs 10-19/30-59 from \$1.63 to \$1.90; Provisional Rate for Medication Support Services, Mode 15, SFCs 60-69 from \$2.18 to \$3.51; and Provisional Rate for Crisis Intervention, Mode 15, SFCs 70-79 from \$2.44 to \$2.83.

11. **Amendment No. 2 (DMH-02299) with Emotional Health Association dba SHARE! the Self-Help and Recovery Exchange**, shifts \$100,000 that was placed in error under CalWORKs-MHS to CalWORKs-Community Outreach Services (COS).
12. **Amendment No. 2 (DMH-02304) with FH & HF Torrance I, LLC dba Sunnyside Rehabilitation and Nursing Care Center and Sunnyside Retirement Center**, amends the Cost Reimbursement Rate for Intensive Skilled Nursing Facility Services, Mode 05, SFCs 30-34 from \$107.20 to \$135.42.
13. **Amendment No. 2 (DMH-02306) with Five Acres – The Boys' & Girls' Aid Society of Los Angeles County**, changes the service delivery site for Provider Number 7286 from 898 North Fair Oaks, Pasadena, CA 91103 to 2055 Lincoln Avenue, Pasadena, CA 91103.
14. **Amendment No. 6 (DMH-02311) with Gateways Hospital and Mental Health Center**, corrects the Intensive Adult Residential Program site address of Provider Number 7603 from 3455 Percy Street, Los Angeles, CA 90023 to 3441 Percy Street, Los Angeles, CA 90023.
15. **Amendment No. 3 (DMH-02318) with Heritage Clinic and the Community Assistance Program for Seniors**, amends the Cost Reimbursement Rates for the following Short-Doyle/Medi-Cal Services: Mode 15, SFCs 01-09 Targeted Case Management Services from \$1.41 to \$1.59; Mode 15, SFCs 10-19/30-59 MHS from \$1.82 to \$2.05; Mode 15, SFCs 60-69 Medication Support Services from \$3.17 to \$3.57.
16. **Amendment No. 8 (DMH-02323) with Institute for the Redesign of Learning**, decreases \$8,750 in Health Families CGF Match, and decreases \$16,250 in Healthy Families FFP Medi-Cal revenue, for a combined total decrease of \$25,000 to the MCA.
17. **Amendment No. 6 (DMH-02332) with The Los Angeles Child Guidance Clinic**, increases CalWORKs in the amount of \$140,000 to expand existing mental health services.
18. **Amendment No. 9 (DMH-02339) with National Mental Health Association of Greater Los Angeles**, adds CGF in the amount of \$24,708 to the MCA to provide additional outreach services for the Latino Access program, Provider Number 7018.

19. **Amendment No. 3 (DMH-02348) with Pasadena Unified School District**, adds \$8,750 in Health Families CGF and adds \$16,250 in Healthy Families FFP Medi-Cal revenue, for a combined total of \$25,000 to the MCA.
20. **Amendment No. 4 (DMH-02348) with Pasadena Unified School District**, increases the Provisional Cost Reimbursement Rates for the following: Targeted Case Management Services from \$1.69 to \$1.88, MHS from \$2.17 to \$2.43, Medication Support Services from \$4.03 to \$4.49, and Crisis Intervention Services from \$3.25 to \$3.61.
21. **Amendment No. 4 (DMH-02351) with Portals**, changes the cost reimbursement provisional rates for the following Short-Doyle/Medi-Cal Services: Adult Residential, Mode 05, SFCs 65-79 from \$102.84 to \$124.77; Targeted Case Management Services, Mode 15, SFCs 01-09 from \$1.58 to \$1.92; MHS, Mode 15, SFCs 10-19/30-59 from \$2.02 to \$2.45; Medication Support Services, Mode 15, SFCs 60-69 from \$3.70 to \$4.49; and Crisis Intervention Services, Mode 15, SFCs 70-79 from \$3.08 to \$3.74. In addition, Outreach Services, Mode 45, SFCs 10-29 a Non-Medi-Cal service will change from \$59.15 to \$71.76.
22. **Amendment No. 5 (DMH-02352) with PROTOTYPES**, adds Department of Children and Family Services (DCFS) funds in the amount of \$173,000 to the MCA for the delivery of mental health services for the Joint Assessment Program.
23. **Amendment No. 9 (DMH-02354) with San Fernando Valley Community Mental Health Center, Inc.**, increases the CalWORKs MHS program allocation in the amount of \$100,000 to the MCA and relocates the Juvenile Justice Programs – Juvenile Probation, Multisystemic Therapy (MST) from 11565 Laurel Canyon Blvd., Mission Hills, CA 91340, Suite 114 from the Filbert Satellite to 14550 Sherman Way, Van Nuys, CA 91405, Provider Number to be determined for FY 2005-06 and any subsequent years. Amends Agreement to relocate the Victory ACT Program from 14411 Vanowen St., Van Nuys, CA 91405 to 14530 Hamlin St., Van Nuys, CA 91411, Provider Number 7252; and amends Agreement to relocate the Transitional Age Youth Intensive Day Treatment and Outpatient Programs from 14700 Friar Street, Van Nuys, CA 91411 to 14545 Sherman Circle, Van Nuys, CA 91405, Provider Number to be determined.
