

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 82 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of February, as follows:

1. **Amendment No. 4 (DMH-01262) with St. Francis Medical Center – Children's Counseling Services**, adds \$74,100 as reimbursement for services rendered for Fiscal Year (FY) 2002-03.
2. **Amendment No. 1 (DMH-01739) with California State University, Long Beach Foundation**, revises Exhibit A (Statement of Work) by decreasing the compensation amount allocated to the Student Professional Development Program by \$106,500, from \$200,000 to \$93,500, to train a reduced number of students.
3. **Amendment No. 3 (DMH-01752) with 1736 Family Crisis Center**, changes the service delivery site for Provider Numbers 7111 and 7348 from 601 South Pacific Coast Highway, Redondo Beach, CA 90277, to 901 West Victoria Street, Rancho Dominguez, CA 90220.
4. **Amendment No. 3 (DMH-01779) with ENKI Health and Research Systems, Inc.**, adds Department of Public Social Services (DPSS) California Work Opportunity and Responsibilities to Kids (CalWORKs) Act funds in the amount of \$180,000 to the Maximum Contract Amount (MCA) for FY 2004-05.
5. **Amendment No. 2 (DMH-01794) with Helpline Youth Counseling, Inc.**, adds the Short-Doyle/Medi-Cal services: Medication Support Services (Mode 15, SFCs 60-69) at the Provisional Cost Reimbursement Rate of \$4.09 at the current service site located at 11849 E. Firestone Boulevard, Norwalk, CA 90650, under the existing Provider Number 7574 for FYs 2004-05 and 2005-06.

6. **Amendment No. 9 (DMH-01815) with Pacific Clinics**, adds \$24,600 in McKinney Projects for Assistance in Transition from Homelessness (PATH) Federal Block Grant (FBG) funds to the MCA to augment mental health services to clients with co-occurring severe mental illness and substance abuse disorders, and who are homeless or at imminent risk of becoming homeless for FY 2004-05.
7. **Amendment No. 10 (DMH-01815) with Pacific Clinics**, adds \$300,000 to the MCA to augment school-based mental health services to the Latina Youth Suicide Prevention program for FY 2004-05.
8. **Amendment No. 2 (DMH-01838) with Step Up on Second Street, Inc.**, adds Non-Early and Periodic Screening, Diagnosis and Treatment (EPSDT) Federal Financial Participation (FFP) funds in the amount of \$120,000, and shift \$120,000 from Other County General Funds (CGF) to Non-EPSDT-FFP CGF Match, for a total increase of \$120,000 added to the MCA, to fund the provision of mental health services to the Assertive Community Treatment Program (ACT) for FY 2004-05.
9. **Amendment No. 3 (DMH-01845) with Trinity El Monte-Trinity Children and Family Services**, adds a new Provider Number To Be Announced (TBA) at Contractor's new service delivery site, located at 11057 Basye Street, El Monte, CA 91731.

The following 13 amendments to Legal Entity Agreements (10 to 22) extend the agencies ability to participate in the Cash Flow Advance (CFA) program from December through February of FY 2004-05:

16. **Amendment No. 1 (DMH-01771) with City of Gardena**, total amount of the monthly CFA payment shall not exceed \$7,627 per month.
17. **Amendment No. 4 (DMH-01777) with D'Veal Corporation dba D'Veal Family and Youth Services**, total amount of the monthly CFA payment shall not exceed \$389,148 per month.
18. **Amendment No. 7 (DMH-01801) with Kedren Community Health Center, Inc., dba Kedren Acute Psychiatric Hospital and Community Mental Health Center**, total amount of the monthly CFA payment shall not exceed \$1,553,856 per month.
19. **Amendment No. 11 (DMH-01815) with Pacific Clinics**, total amount of the monthly CFA payment shall not exceed \$4,149,222 per month.
20. **Amendment No. 2 (DMH-01823) with Portals**, total amount of the monthly CFA payment shall not exceed \$962,491 per month.
21. **Amendment No. 2 (DMH-01837) with St. Joseph Center**, total amount of the monthly CFA payment shall not exceed \$40,684 per month.
22. **Amendment No. 3 (DMH-01838) with Step Up On Second Street, Inc.**, total amount of the monthly CFA payment shall not exceed \$187,037 per month.

The following five (5) amendments to Legal Entity Agreements (23 to 27) restore Healthy Families funds for the duration of their Agreement:

44. **Amendment No. 1 to Medi-Cal Professional Services Amendment with three (3) group providers**, adds Board-mandated revised language for FYs 2004-05 and 2005-06: Child Support Compliance Program; Contractor Responsibility and Debarment; new Certification Regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion; and temporarily adds provisional payment language from July 1, 2004, until the Integrated Systems (IS) is fully functional for FY 2004-05.
45. **Amendment No. 2 to Medi-Cal Professional Services Agreements with three (3) individual providers**, adds additional Health Insurance Portability and Accountability Act (HIPAA) language; adds a Guide to Procedure Codes and includes a "crosswalk" of technical terms, definitions, and language; deletes Exhibits B, B-1, B-2, and B-3 and replaces them with a Trading Partner Agreement; and adds Electronic Data Interchange/Direct Data Entry (EDI/DDE) Selection, General Requirements Agreement, and Claim Submission Agreement.

46. **Amendment No. 3 to Medi-Cal Professional Services Agreements with three (3) individual providers**, changes the Contractor's Exclusion from Participation in a Federally Funded Program language, adds Attestation form, and includes the Board-mandated Preamble.
47. **Amendment No. 4 to Medi-Cal Professional Services Agreements with three (3) individual providers**, temporarily adds provisional payment language for the period effective October 16, 2003, until the IS is fully functional and adds contract language in regards to "No Payment for Services Provider Following Expiration/Termination of Contract."
48. **Amendment No. 5 to Medi-Cal Professional Services Agreements with three (3) individual providers**, updates Child Support Compliance Program language and adds a Board-mandated clause regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion.
49. **Amendment No. 5 to Medi-Cal Professional Services Agreements with one (1) individual provider**, temporarily adds provisional payment language for the period effective October 16, 2003, until the IS is fully functional and adds contract language in regards to "No Payment for Services Provider Following Expiration/Termination of Contract."
50. **Amendment No. 6 to Medi-Cal Professional Services Amendments with sixteen (16) group providers**, updates Child Support Compliance Program language and adds a Board-mandated clause regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion.
51. **Amendment No. 1 to Clinical Assessment Program Agreements with five (5) clinicians**, combines the Statement of Work Exhibits A and A-1, and Payment Schedule Exhibits B and B-1, to enable AB 3632 and D-Rate services to be performed by all assessors.
