SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 209 amendments to existing Legal Entity Agreements, Specialized Agreements, Pharmacy Agreement, Medi-Cal Psychiatric Inpatient Hospital Services Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of April, as follows:

1. **Amendment No. 5 (DMH-00908) with Aurora Charter Oak, LLC**, increases the Acute Psychiatric Inpatient Hospital Services rate from \$460 to \$560 per day and the Administrative Day Services rate from \$287.86 to \$389.13 for Fiscal Year (FY) 2003-2004.
2. **Amendment No. 1 (DMH-01075) with VIP Community Mental Health Center**, expands the scope of services to include eligible Title XXI Healthy Families Program Members (HFPM) for FY 2001-2002.
3. **Amendment No. 4 (DMH-01168) with VIP Community Mental Health Center**, restores the Healthy Families program for FY 2002-2003 and any subsequent years that were inadvertently superceded on October 1, 2002.
4. **Amendment No. 2 (DMH-01020) with California State University, Long Beach Foundation**, revises the compensation amount from \$300,000 previously allocated to the Student Professional Development Program to train a maximum of 42 students to \$270,600 to pay 33 students who qualified for stipends this fiscal year and who were placed in the Department of Mental Health's (DMH) mental health clinics for FY 2003-2004.

5. **Amendment No. 2 (DMH-01025) with California State University, Long Beach Foundation**, increases the total compensation from \$195,900 to \$330,000 for FY 2003-2004. This additional increase of \$134,100 reflects the revised number of stipends, tuition slots, program staff, and administrative costs.
6. **Amendment No. 3 (DMH-01237) with Los Angeles Unified School District**, restores the Healthy Families program for FY 2002-2003 and any subsequent years that were inadvertently superceded on October 2002.
7. **Amendment No. 1 (DMH-01288) with Intra Drugs Artesia**, changes the business address from 1241 E. Artesia Blvd., Compton, CA 90221 to 403 S. Long Beach Blvd., Suite C, Compton, CA 90221.
8. **Amendment No. 5 (DMH-01435) with ASC Treatment Group dba The Anne Sippi Clinic**, adds County General Funds (CGF) (All Other CGF) in the amount of \$245,000 to fund an increase of 10 treatment beds for the residential mental health treatment program for FY 2003-2004.
9. **Amendment No. 7 (DMH-01437) with Associated League of Mexican-Americans, Inc. dba ALMA Family Services**, adds a new service site located at 4701 E. Cesar Chavez Ave., Los Angeles, CA 90022, for the provision of on-site mental health services to adult and children.
10. **Amendment No. 5 (DMH-01441) with Children's Bureau of Southern California**, adds a new service site located at 460 E. Carson Plaza Dr., Suite 103, Carson, CA 90746.
11. **Amendment No. 4 (DMH-01447) with Didi Hirsch Psychiatric Service**, makes a technical adjustment to the Children's System of Care (CSOC) – State General Funds (SGF) allocation, of which \$120,415 was originally included in the Agreement, with the following breakdown: \$18,110 in CSOC – SGF for Flex funds and \$73,000 in CSOC – SGF for mental health services; decreases AB 2994 in the amount of \$5,000 from the Maximum Contract Amount (MCA); replaces the applicable Service Exhibit with the following revised Service Exhibit- Day Treatment Intensive Services (Children/Adolescents) (Rehabilitation Option) and Therapeutic Behavioral Services (TBS); adds contract monitoring language for the notification by Contractor to County when 75% of the MCA is incurred and within six months of expiration; and includes the Board-mandated Preamble.

12. **Amendment No. 5 (DMH-01474) with Olive Crest Treatment Center, Inc. dba Olive Crest**, changes the name of Contractor's program from Olive Crest Treatment Center-Wraparound to Olive Crest Treatment Center located at 15545 Bellflower Blvd., Suite A, Bellflower, CA 90706, under existing Provider No. 7534, due to the consolidation of both Wraparound and Foster Family/Adoption Agency Programs and deletes Provider Number 7533 previously associated with the Wraparound program.
13. **Amendment No. 5 (DMH-01479) with San Gabriel Children's Center, Inc.**, deletes Mode 10, Service Function Codes (SFC) 95-99, from Provider Number 7274 and replaces the applicable Service Exhibit with the following revised Service Exhibit--Day Treatment Intensive Services.
14. **Amendment No. 3 (DMH-01483) with St. John's Hospital and Health Center**, decreases AB 2994 funds in the amount of \$28,343 from the MCA; replaces the applicable Service Exhibit with the following revised Service Exhibit--Day Treatment Intensive Services and TBS; adds contract monitoring language for the notification by Contractor to County when 75% of the MCA is incurred and within six months of expiration; and includes the Board-mandated Preamble.
15. **Amendment No. 5 (DMH-01511) with ENKI Health & Research Systems, Inc.**, makes a technical correction to reform the contract by revising the contracted provisional Negotiated Rate for Mental Health Services from \$1.97 to \$1.65 for FY 2003-2004.
16. **Amendment No. 7 (DMH-01533) with Pacific Clinics**, makes a technical adjustment to Amendment No. 6 to change and accurately reflect the effective date of the new service sites identified as Pacific Clinics' Eggleston Mental Health Program and PRC Transitional Youth Services, located at 13001 Ramona Blvd., Suite E, Irwindale, CA 91706, and 1811 Raymond Ave., Pasadena, CA 91103, from January 1, 2004 to November 1, 2003 and changes the service site of the ACT Program from 10642 Lower Azusa Road, El Monte, CA 91731, to 9864 Baldwin Place, El Monte, CA 91731, effective November 1, 2003.
17. **Amendment No. 8 (DMH-01533) with Pacific Clinics**, changes the service site of Pacific Clinics' Hye-Wrap Program from 1614 E. Colorado Blvd., Glendale, CA 91205 to 237 N. Central Ave., Glendale, CA 91203, under Provider Number 7502A; makes a technical adjustment to the Legal Entity Agreement Service Delivery Site Exhibit to accurately reflect service sites identified as Pacific Clinics' D'Veal CEC and Oak Knoll School Outpatient Programs, effective July 1, 2003;

adds the D'Veal CEC Outpatient Program located at 855 N. Orange Grove Blvd., Pasadena, CA 91103, under Provider Number 7462 A&B; and changes the service site of the Oak Knoll School Intensive Day Treatment Program located at 325 S. Oak Knoll Ave., Pasadena, CA 91101, to Oak Knoll School Outpatient Program located at 330 S. Oak Knoll Ave., Pasadena, CA 91101, under Provider Number 1974K.

18. **Amendment No. 9 (DMH-01540) with South Central Health and Rehabilitation Program (SCHARP)**, provides clarification that the provisions set forth in Amendment No. 6 under Agreement No. DMH-00905, which was superceded to Agreement No. DMH-01166 and DMH-01540, respectively, have not been superceded and have at all times remained in effect.
19. **Amendment No. 2 (DMH-01543) with St. Francis Medical Center – Children's Counseling Center**, increases Federal Financial Participation (FFP) Medi-Cal funds in the total amount of \$30,898 and decreases EPSDT – SGF in the amount of \$29,600 in order to implement the FMAP Adjustments for both non EPSDT – FFP and EPSDT – FFP Medi-Cal revenue for FY 2003-2004.
20. **Amendment No. 2 (DMH-01583) with St. Mary Medical Center**, increases the Administrative Day rate from \$295.45 to \$296.03; adds contract monitoring language for the notification by Contractor to County when 75% of the MCA is incurred and within six months of expiration; and includes the Board-mandated Preamble.
