SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 311 amendments to existing Legal Entity Agreements, Specialized Agreements, Community Care Residential Facility Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of June, as follows:

1. **Amendment No. 2 (DMH-00942) with Devereux Texas Treatment Network**, increases daily rates from \$90.53 to \$91.28 for the long-term adolescent program; from \$124.23 to \$125.16 for the young adult program; from \$128.86 to \$129.70 for the evaluation and stabilization program; and from \$50.02 to \$51.84 for the children's treatment program for Fiscal Years (FY) 2002-2003 and 2003-2004. There is no change in the Maximum Contract Amount.
