Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 73 Amendments to existing and/or new Legal Entity (LE) Contracts, Specialized Contracts, Mental Health Services Act (MHSA) Contracts, Medi-Cal (MC) Professional Services Contracts (Individual and Group Providers), Clinical Assessment programs, and execution of four new Contracts processed in the month of September 2018 as follows:

- 1. Contract (MH121665) with Five Acres The Boys' & Girls' Aid Society of Los Angeles County is a newly executed County Interim Settlement Process Agreement for Fiscal Year (FY) 2013-14. The term of this Agreement commenced upon execution, and shall continue in full force until the agency has satisfied its obligations under this agreement or the Annual Cost Report Reconciliation and Settlement is complete, whichever occurs later.
