## NOTICE OF INTENT TO RELEASE A REQUEST FOR STATEMENT OF QUALIFICATIONS FOR THE PROVISION OF PROJECT MANAGEMENT SERVICES BID NO. DMH110918B1

The Los Angeles County Department of Mental Health (DMH) is issuing this Request for Statement of Qualifications (RFSQ) to establish a Master Agreement List of qualified Vendors interested in providing Project Management services. Vendors determined to meet the minimum requirements identified in Section 1.5, Vendor's Minimum Qualifications, are invited to submit a Statement of Qualifications (SOQ). The SOQ must be prepared in accordance with Section 2.0, Instructions to Vendors, of the RFSQ.

A Project Management Services Master Agreement will be offered to all vendors qualified in one or more Project Management service categories. Upon execution of the Master Agreement, qualified vendors will become County contractors and, depending on demonstrated experience and qualifications in one or more of the Project Management service categories, may be solicited under competitive solicitations.
