- 2. Diversion efforts conversations ongoing with justice partners to create diversion program with initial phase at Central Courthouse. Will require revamp of MHCL program and redeployment of staff. Details continue to develop
- 3. Legislative Priorities LPS Audit hearing—hopefully the audit shows how is it working and how is it not working. DMH will participate in hearing.
- 4. Citizenship question on census positive determination was made by supreme court
- 5. Lack of access to hospital beds for youth looking at creating a motion statewide because beds continue to be a critically unavailable for youth

# **Commissioner Reports**

# **Eric Matos – 5<sup>th</sup> District Representative**

- Announcement Federal government approved efforts to engage an audit on LPS. Efforts will look into disparities
  especially in 5150 situations adding medical criteria to the grave disability issues. Will stay focused on the status
  and continue to update MHC.
- Supervisors' Office is actively pursuing the state to apply for IMD Medicaid reimbursements for facilities with 16 or more beds. Medicaid reimbursement will maximize beds in facilities.

## **Commissioner Cooperberg**

- Joined SCV suicide prevention committee due to a spike in suicides in the valley.
- Attended SCV interfaith clergy breakfast well attended by a diverse group of clergy representatives.
- SCV ad hoc headed by Larry Schallart is working with the City of Santa Clarita to develop an anti-suicide media campaign.

#### **Commissioner Murata-Shih**

• Continue tracking Kaiser Permanente mental health employee's union contract. Before going on strike, the union asked the employees to return to the table to renegotiate the contract.

## **Commissioner Dalgleish**

Attended the quarterly California Association of Local Behavioral Health Boards and Commissions (CALBHBC)
meeting in Santa Ana. Board and commission trainings were very helpful. Recommended all groups to attend a
CALBHBC training to learn more about board rules and regulations.

**Anna** – AV WOW volunteer reported transportation is needed for volunteers to come to recommended trainings **Rosemary Jenkins** – Works with juvenile offenders. Promotes juvenile offender success stories to use as a resource for DMH.

### Marvin Thompson -

- 1. Expand linguistic and language issues in the Asian and Arabic communities because they are the largest among languages.
- 2. Service Area 6 has not been to a Commission meeting lately.

**William Legere**— Regarding supportive employment since the current president's election employment has gone down in the African-American and Asian population.

**Gilbert LaBlonc** – Help the homelessness issue in the SFV area by providing cots and bathroom facilities in the abandon post office in Van Nuys and other abandon buildings nearby.

**Jean Harris** – Issues with the homeless count connected to the Kern and Los Angeles County boundary is a misrepresentation. Kern County is included in the LA County count but do not receive any resources.

**Barbara Wilson** – B&C continuously receive a push from other county departments offering more dollars to use licensed available beds

Maria Tan – Restroom access in PRC and elevators in DMH create building problems

## **Discussion: Homeless Count Strategy**

# **Commissioner Comments/Recommendations**

Look specifically into the service areas to evaluate what is better and what is declining so MHC can target specific areas Every service area had a percentage decrease in homeless count report

Data in service area 1's individual homeless count report stated percentages diminished about 38%

So many factors to determine if the data is accurate

Take a preventative stand on reducing homelessness not just what is happening to homeless people. Utilize public comments from MHC meeting for suggestions or recommendations

Recommend using homeless issues or complaints spoken at today's public comment

ACTION – What % of MHSA funding is spent on homeless programs versus people in homes

ACTION – Add "Report on Homelessness" standing item on monthly agenda
