Department of Mental Health Report - Curley Bonds, II, Chief Deputy Director, Clinical Operations

Dr. Bonds reported the following:

We Rise – ongoing through the Memorial Day Weekend. Three leading mental health reform advocates Mia St. John, Mädchen Amick and Muriel Hemingway addressed serious mental illness concerns in a challenging and important conversation.

Service Area Visits –completed all 8 SAs during months of April & May

- 1. Staffing Patterns some clinics are understaffed seriously compared to peers. We anticipate adding more clinical and administrative positions to those most affected because of final changes to the DMH budget, submitted earlier this month.
- 2. Facilities several are in need of more space or repairs
 - a. HR will be moving from San Pedro to City of Commerce this will make room for HOME outreach teams
 - b. Safety for staff-looking at increasing security, increase parking spots

Outpatient Division Issues

- 1. We are posting a position for County-wide Deputy will be in charge of working with those who are unengaged: HOME, HST (Homeless Services Teams), AOT and Veteran's Programs
- 2. Mobile TMS (Transcranial Management Stabilization) program now has been established, leadership of Mr. Marc Heiser, MHSA funded program

DMH Internal Structure Issues

- 1. With retirement of Mary Marx we are going through transitions
- 2. Now under leadership of Dr. David Ruskin, Chief of Psychiatry
- 3. Mercer Report draft is being reviewed

Public Guardian's Office

- 1. Working toward reclassification of positions and posting positions
- 2. Closely monitoring SB 1045 housing conservation bill it required a serious mental illness, SUD (substance use disorder) and experienced homelessness.
- 3. The impact DMH decided would be small, because it would apply to fewer than 30 people in LA County, but they would be amongst our highest users

Justice Involved Division

- 1. Will be posting a position to oversee Justice Involved, Chief of Psychiatrist, Specialty
- 2. Working with courts to implement AB 1810 plan is to have a hub at Clara Foltz **Shortridge Court House**

- There were 284+ hospilizations in 4 months at a facility with 18 beds in the Antelope Valley. MET recorded the number the highest 5150 in the county.

Downtown Mental Health refuse to give my clonazepam 0.5 mg Dr. Kimberly Novak said that Downtown Mental Health does not prescribe my clonazepam 0.5mg. Dr. Paul Sihuk did prescribe my clonazepam 0.5mg of last year at San Fernando Mental Health. LAFH have bed bugs because DMH participant is afraid to come back to LAFH of the bed beds.
