Welcome and Introductions

Participants introduced themselves and proposed questions to address at the learning network: how outcomes are used; how to get therapist buy-in; reducing ECBI high Unable to Collects; how to address practice implementation concerns in residential settings; increasing parent buy-in.

G. Eckart presented "A Closer Look" at PEI Outcomes data that looked at: potential population shifts over time; client outcome measure pre scores at the start of treatment at 6-month intervals; trends in pre to post score change w/ consistent pattern of mild improvement at each six month interval; score trends for individual YOQ/YOQ-SR subscales; trends in treatment outcomes for clients w/ pre scores that started at/above the clinical cutoff vs. clients w/ scores that started below the cutoff; ART

"dose response" trends based on pre/post score analysis; data entry trends over time. K. Taguchi asked group if it'd be helpful to separate ART Skillstreaming from ART, S. Alkass then suggested separating by age. The PEI Outcomes team will explore separating out ART from ART Skillstreaming given that there might be enough data to separate out the two practices now. Data will be reviewed to see if the differences in the two programs account for the large variation in the data.

M. Villaescusa reviewed the demographic, detailed, and counts by provider reports.

- S. Alkass discussed need for ART specific supervision and prompted a discussion participants had about ART fidelity monitoring, w/ participants sharing group supervision techniques and video review. Participants discussed the following topics: increasing clinician buy-in to ART w/ participants sharing buy-in strategies; clinician aversion to working w/ a population believed to be "aggressive"; some clinician dislike group treatment; clinician frustration w/ high administration requirements; difficulty collecting outcome measures. Participants indicated a recent change to the Anger Control Module and inquired if the Anger Control Module could be used for younger ages. S. Alkass will follow-up with developer and provide an update. Participants reported success in using the baseline spreadsheet and G. Eckart announced a revised version is available and to email PEloutcomes @dmh.lacounty.gov to request it.
