JULY 2019

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 50 Amendments to existing and/or new Legal Entity (LE) Contracts, Specialized Contracts, Mental Health Services Act (MHSA) Contracts, Medi-Cal (MC) Professional Services Contracts (Individual and Group Providers), Clinical Assessment programs, and execution of two new Contracts processed in the month of July 2019 as follows:

- 1. **Contract (MH190163) with Ella's Foundation** for Fiscal Year (FY) 2019-20 extends the term of the Contract effective July 1, 2019, and continues on a month-to-month basis through June 30, 2020.
- 2. Contract (MH290890) with EB Psych Solution, Inc., is a Fee-for-Service Renewal Contract. The term of this Contract commenced on July 1, 2019, and shall continue in full force through June 30, 2024.

The following one Amendment (3) extends the term of the Contract, deletes, and replaces Exhibits:

- 7. Amendment No. 9A (MH122040) with San Gabriel Children's Center for FY 2018-19 and any subsequent fiscal years during the term of this Contract adds two new provider site addresses for the provision of Short Term Residential Therapeutic Program services.
- 8. Amendment No. 7A (MH122049) with St. Joseph Center for FY 2019-20 and any subsequent fiscal years adds a new service delivery site under new PN to be assigned (TBA), located at 8525 S. Broadway Street, Los Angeles, CA 90003. Adds the following service exhibits: Targeted Case Management Services, Mental Health Services, Medication Support Services, Crisis Intervention Services, Outreach Services, Client Supportive Services, One-Time Expenses Associated with Implementing a New MHSA Program for Prevention and Early Intervention (PEI) Program and Recovery, Resilience and Reintegration (RRR) Services.

Amendment No. 5 (MH122023) with The People Concern for FY 2018-19 decreases MHSA FSP MC Funded Program funds in the amount of \$300,000; increases MHSA FSP Non-MC Funded Program funds in the amount of \$150,000; decreases MHSA RRR Services MC Funded Program funds in the amount of \$100,000; and increases MHSA RRR Services Non-MC Funded Program funds in the amount of \$50,000. The revised MCA is \$8,075,486.
- 11. Amendment No. 9 (MH122039) with San Fernando Valley Community Mental Health Center, Inc., for FY 2018-19 increases MHSA PEI Invoice Funded Program funds in the amount of \$25,000. The revised MCA is \$40,552,703.
