Review of minutes	 August meeting minutes approved <u>Questions</u> How is the outreach to the universities going? Mirtala, Angela, and Kelly met with Rita Ledesma, Associate Dean from CSULA, to discuss collaborating together to engage more Native American college students in the subcommittee. We are hoping to have her come to our November meeting to discuss her goals with the subcommittee. Kelly is also outreaching to CSUN and CSULB. Recommendation to outreach to UCLA as well. What is the status of the USCC Graduate Recruitment Program? We received an email this week from the coordinators of that program asking for the email list for the subcommittees. So you should be receiving an email from them soon informing you that anyone who is interested can apply. Since the hiring practice for DMH is based on item availability, what would we do if we had a candidate for the USCC Graduate Recruitment Program but we didn't necessarily have an item for them (i.e. Case Manager, PSW, Mental Health Clinician), is DMH going to help us to create an item so they can be placed at our clinic? That would be an HR question, but we can express your concerns once this issue is presented. One of the priorities of DMH right now is to make sure that the workforce reflects the cultures of the Consumers and is more ethnically/culturally diverse. That's definitely something we can bring to the USCC Leadership meeting.
Announcements	 <u>Co-Chair Election</u> Belinda Smith (DMH) and Michelle Enfield (community) were elected as the new co-chairs Mirtala to schedule conference call with new co-chairs to discuss roles and expectations The co-chairs will participate in the UsCC Leadership Meeting, which reports to the SLT regarding the needs of the community

	 Mirtala reviewed some of the other expectations of the co-chairs including facilitating the meetings and assisting with the agenda, as well as attendance at 75% of the subcommittee meetings Mirtala explained the SLT seat process as well, including Sunnie Whipple taking over that seat (Sunnie to come present periodically at subcommittee regarding SLT matters) Once the UsCC Rules & Agreements are approved, we will distribute them and enforce them-one of the pending changes is that in order to have voting privileges, members must attend (by phone or in person) at least 50% of the meetings Questions What is the purpose of the UsCC Leadership meeting? Whatever information/feedback comes out of the Leadership meeting funnels into the SLT and as a body they make recommendations pertaining to how we can effectively serve the diverse cultural communities throughout the County of Los Angeles.

	 Questions Can the money be used to buy shelter beds? It has to be mental health promotion, outreach, engagement, retention and penetration. It cannot be used for direct or supportive services.
	 Next Steps Kelly to send out an email to the subcommittee to elicit more project proposal ideas (150 words or less) Once we have the list, we will bring it back to the next subcommittee meeting to be discussed further
