SLT – Update	<ul> <li>Sunnie Whipple updated the subcommittee regarding SLT</li> <li>Dr. Sherin is interested in starting a peer program related to communities addressing trauma and using trauma informed approaches that include peer support-especially in times of crisis</li> </ul>
