- Adding/removing/modifying the Other Health Coverage (OHC) indicator from State eligibility records

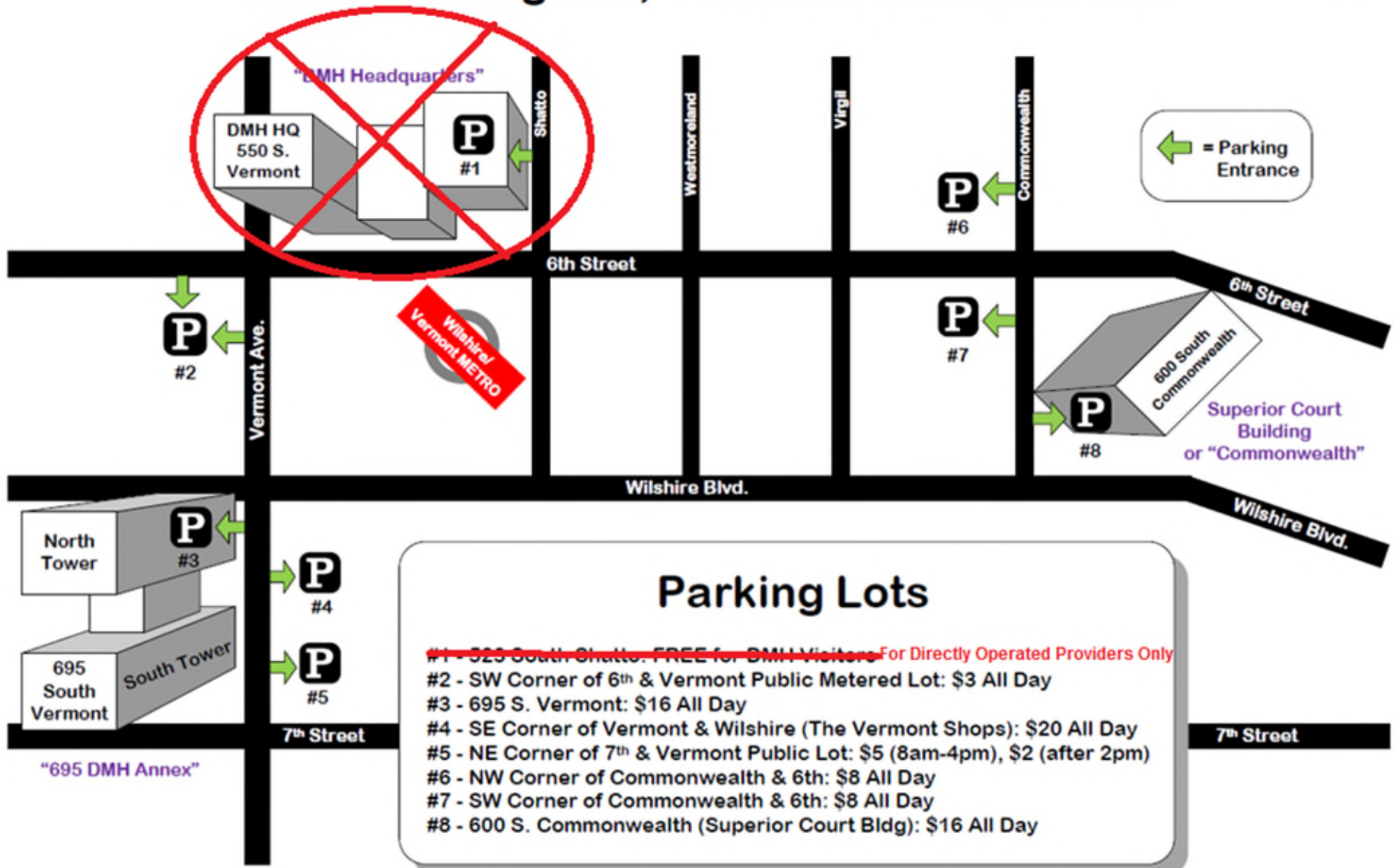
