	<ul> <li>The department will not be adding additional funding. For the last 5 years there has been \$100,000 of funding and it's been a year and half that they raised it to \$200,000. No more monies will be added at this time. They are looking into a process for the SAACs who do not currently have any funding-DMH is looking into investing some money for them.</li> </ul>
	EQRO = External Quality Review Organization:
	<ul> <li>LA County receives Federal and State funding. EQRO reviews our Medi-Cal dollars. It looks at our system and it looks at the recipients of Medi-Cal. They are hired by the State to do annual reviews. They report to the State what each of the Counties are doing and these reviews lead to the Tri-Annual review, which is the Medi-Cal review. They look at the Access to Care, that is where the UsCCs fall. They look into what LA County is doing to reduce Mental Health Disparities. We show even though we are trying, the disparities are still there.</li> </ul>
