These requirements include that a clinician is trained in the instrument, that they hold, at least, a bachelor's degree in psychology or a related field and that they are supervised by a trained master's level clinician or higher.</li> <li>In addition, prior to administering the PTSD-RI-5 via video or phone it is advisable to have a clinical relationship with the client in order to obtain valid data as well as to respond clinically to client if the subject matter of this measure triggers the client or exacerbates symptoms.
