## SHORT-DOYLE/MEDI-CAL AID CODE MASTER CHART

Eligible individuals applying for Medi-Cal who qualify for benefits are placed into specific programs based on their age, income, and medical need. Medi-Cal documents aid codes for all programs in the Aid Code Master Chart. The Aid Code Master Chart tells mental health providers the eligibility requirements for each Medi-Cal aid code, the type of coverage, and when mental health services are payable by the Medi-Cal program. To determine whether an aid code returned on a Medi-Cal eligibility check reimburses for medically necessary, specialty mental health services provided to Medi-Cal eligible beneficiaries, refer only to the Short-Doyle/Medi-Cal Aid Code Master Chart.

On March 13, 2020, Short-Doyle/Medi-Cal released an update of the Aid Code Master Chart. All providers are required to verify Medi-Cal eligibility on the day of service in order to submit claims for Medi-Cal reimbursement and can use the updates listed in this document. Remember that all clients with restricted Medi-Cal must be screened for an UMDAP.

Restricted to all covered emergency, including mental health (Title XIX) and all covered pregnancy-related (Title XXI) services only.	12/1/16
L6	Full	No	Disabled/Blind -age 19 through age 64. 0% to 128% FPL, citizen/satisfactory.	1/1/14
L7	Restricted	No	Disabled/Blind -age 19 through age 64. 0% to128% FPL, undocumented.	1/1/14
R1	Full	No	State-funded cash assistance and full-scope Medi-Cal benefits with no SOC for non-citizen trafficking and crime victims eligible for TCVAP benefits. Covers non-citizen victims of human trafficking, domestic violence or other serious crimes who meet the TCVAP program eligibility requirements. Title XIX provides funding for emergency services and non-emergency services that are not pregnancy-related. Title XXI provides funding for Pregnancy Related services.	11/1/18
