Voting members took a motion to appoint Shannon Rivers and Sylvia Youngblood for the Co-Chair positions as there are two vacancies, and no other nominees. Kelly will send out Bios via email and will follow up with Co-Chairs regarding stipends. Farrah Ferris has been a Co-Chair for the Al/AN subcommittee for almost two years now. Her term will end in August 2020. She is looking forward to passing on the baton to the new nominees. She will continue to support the subcommittee and will continue to attend meetings. Robyn Gomez graciously and kindly had to decline her nomination for Co-Chair due to her schedule being full, but will continue to support and attend meetings. Bernice Mascher suggest/shared that there should be a third alternate Co-Chair.

General Announcements - Subcommittee Members	 Sunnie Whipple shared his concerns with how COVID-19 is affecting the Native community and with regards to the Los Angeles County layoffs. Kelly shared the message she received from Executive Management and Human Resources that they are doing everything they can to prevent layoffs from happening at all. Dr. Sandra Chang shared that certain sites in Los Angeles County are facing the possibility of layoffs and that this is across all County departments, including DMH. Sunnie Whipple inquired whether AICC (American Indian Counseling Center) would be closing. Kelly shared that there were no plans for that, but that she would follow up. Sunnie Whipple would also like to see the new Co-Chairs that are appointed participate in an orientation before their term starts.
