II. Department of Mental Health Update

Dr. Jonathan Sherin, Director Mental Health – Trieste Innovation Project Update

COVID-19 impacted DMH flexibility of funding streams for MHSA Innovation programs like Trieste. The state has yet to settle the future of the Innovation budget. Resources built in the Trieste project are still possible for DMH to develop a way to utilize the project. The Hollywood area has no crisis residential resources, FSP program is not adequate and the clinic needs help. DMH is working with Supervisor Kuehl and staff to redirect funding to backfill gaps. Moving forward with the FSP remodel (FSP 2.0) the plan will provide services 24/7 to keep persistently mental health clients out of jail, out of the hospitals, and off the street. FSP 2.0 remodel will launch July 2021.

Homeless Outreach Mobil Engagement (HOME) Team – (Key Priority Program – serving the most vulnerable)

- a. LPS Outpatient Conservatorship Pilot has successfully conserved 1 individual with 3-4 others in pipeline Program Benefits:
 - · Focuses DMH staff, resources, and authority on our mandated target population

- · Provides a pathway for mental health treatment and care for those who need care the most
- · Minimizes trauma associated with involuntary treatment
- · Provides treatment and housing in the least restrictive setting
- · Provides continuity of care and evidentiary testimony from those who know the client best
- · Reduces unnecessary strain on acute hospital system
- · Assumes recovery is possible given the proper support
- · Examines client needs from end point to end point, to develop a comprehensive recovery roadmap that guides clinical decision making
- · Identifies and improves systemic deficiencies through ongoing intra/inter departmental collaboration
- b. LA Alliance Lawsuit (Honorable Judge David Carter-Presiding)

On March 10, 2020 the LA Alliance for Human Rights in collaboration with multiple individuals experiencing homelessness in Los Angeles County, filed a civil rights suit against the city and county of Los Angeles. There are 14 allegations outlined in the filing which, in short, allege that both entities neglected their responsibility to provide housing and care for people experiencing homelessness (PEH) in Los Angeles City/County. The suit seeks to establish an enforceable legal mandate to provide beds and wrap around services for (PEH) (similar to New York's Right to Shelter). Additionally, there are components which seek deadline-driven plans to reduce encampments, increase social outreach and ensure care for PEH.

DMH staff have been pulled in multiple directions as Judge Carter identifies specific projects (i.e. encampments, freeway overpasses etc.) that he wants cleared. In these instances, our HOME staff are called upon to provide immediate responses to support cleanup efforts with real time mental health intervention irrespective of planned services/visits or needs of existing HOME clients. COVID-19 has reduced HOME staffing to 60% (not factoring in vacancies). With the added expectation of immediate response to various Judge Carter directives we are even more depleted.

- c. Emergency Outreach & Triage Division (EOTD) LET/PMRT
 - 1) Therapeutic Transportation Slated to start in January (5 vans outfitted; staff are being hired), an alternative to calling for an ambulance or law enforcement. Units will have Community Health Worker, Psych Tech and Driver
 - 2) Outpatient Triage Teams/Child Outpatient Triage Teams
 - Contractors are slated to go live with 1 team per SA in November
 - Should reduce need for multiple interventions by PMRT

DISCUSSION

Ezekiel Reyes – Failure to understand the difference between being housed and homelessness does not expediate mental illness. Recommends a collaboration of county departments address the lack of food funding to assist with food shortage.

Jean Harris – How will Measure J if passes affect the DMH budget? Can I review the budget?

Osbee Sangster – Speaking on behalf; of the Black Los Angeles County Client Coalition, I would like to take this moment to reiterate BLACCC's advocacy effort; with all do respect the Countywide (Client) Activity Fund/CAF. Discussed issues with rules and mandates in the new CAF.

Mark Karmatz – Spoke about Dr. Southard meeting monthly with clients. Dr. Sherin does not meet with clients and where is SLT?

Pete Thompson – Therapy content of treatment in Los Angeles communities have PSTD issues and triggers child sex abuse. Forgiveness cannot be accomplished. Family members cannot be supported

Barbara Wilson – LA Times article on unregulated and unlicensed facilities are being identified. Can we advocate for more licensing?

We have great support from our DMH colleagues we are able to secure presenters, provide updates and get core member community updates to provide feedback for the department. We had a presentation on MHSA data during the October meeting and continue to average around 50 participants at meetings. With that said two priority needs from the feedback from our area revolve around bringing more voices to the table. Support around the shift to virtual meetings we have a lot of old adult participants who need assistance to use technology and consumers who have had difficulties with accessing equipment as well as negatively impact by losing CAF and the new CAF meeting attendance requirements, so they are not participating as often. Secondly, it is great that we have meeting translator, but we have a diverse group of languages we need to have information translated for the agendas and meeting invites to bring more people to the table. Key struggles this month: we continue to have concerns revolving around the impact of the pandemic.
