Medi-Cal Certification Bulletins 19-01 and 19-02	Bulletins are available for Medi-Cal certification in the DMH website. Medi-Cal activation date- is the first date Medi-Cal claims can be submitted to The Department of Health Care Service (DHCS) for reimbursement of services rendered to Medi-Cal Beneficiaries. DHCS determines these dates by the following:  1) Date the Provider requested Certification. 2) Date the site was Operational 3) Date of Fire Clearance. The Medi-Cal Activation Date is determined by the latest of the above three dates. Fire clearance 850 Form needs to be completed only if requested- Can contact Renee for assistance in obtaining and providing requested form. Fire clearances are optional for providers located on public school sites.
